ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984 and of all other powers enabling him in that behalf, for the purpose of informing road users of parking places for Car Club members on roads for which the London Borough of Hammersmith and Fulham is the traffic authority, hereby:-

1. authorises the placing at appropriate sites of a traffic sign (hereinafter referred to as “the authorised sign”) conforming as to size, colour and character with that shown on the attached drawing numbered NP 660.3A, save that the code identifier patch may be omitted or varied and that the borough arms and name may be added; and
2. authorises the placing at appropriate sites of a traffic sign consisting of a road marking (hereinafter referred to as “the authorised marking A”) conforming as to size, colour and character with that shown at diagram 1028.3 in the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, “the 2002 Regulations”) except that the word “DOCTOR” shall be replaced by “CAR CLUB ONLY”; and
3. authorises the placing at appropriate sites of a traffic sign consisting of a road marking (hereinafter referred to as “the authorised marking B”) conforming as to size, colour and character with that shown at diagram 1028.4 in the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, “the 2002 Regulations”) except that “CAR CLUB ONLY” shall be added; and

4. authorises the placing at appropriate sites of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking C") conforming as to size, colour and character with that shown at diagram 1032 in the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") except that "CAR CLUB ONLY" shall be added; and
5. directs that the authorised markings A, B and C may be used only with the authorised sign; and
6. directs, that it is a condition of this authorisation that the authorised sign and the authorised markings A, B and C shall only be placed to indicate the effect of a corresponding Traffic Order; and
7. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the placing of the authorised sign and the authorised markings A, B and C at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and the authorised markings A, B and C and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign NP 660.3A in the same manner as they apply to the sign shown in diagram 660.3 in Schedule 2 to those Regulations.



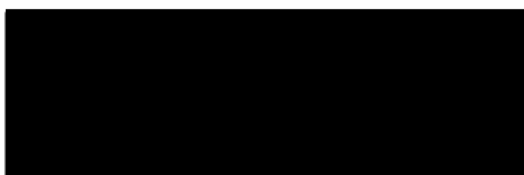

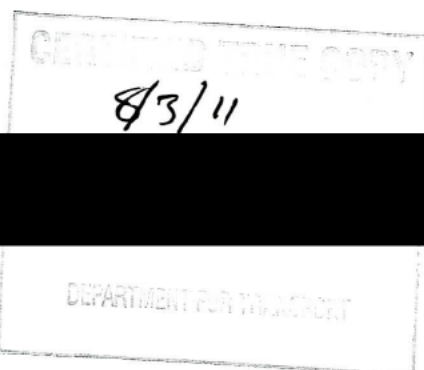
The provisions of Regulations 12 and 31 of the 2002 Regulations shall apply to the authorised marking B in the same manner as they apply to the road marking shown in diagram 1028.4 in Schedule 6 to those Regulations.

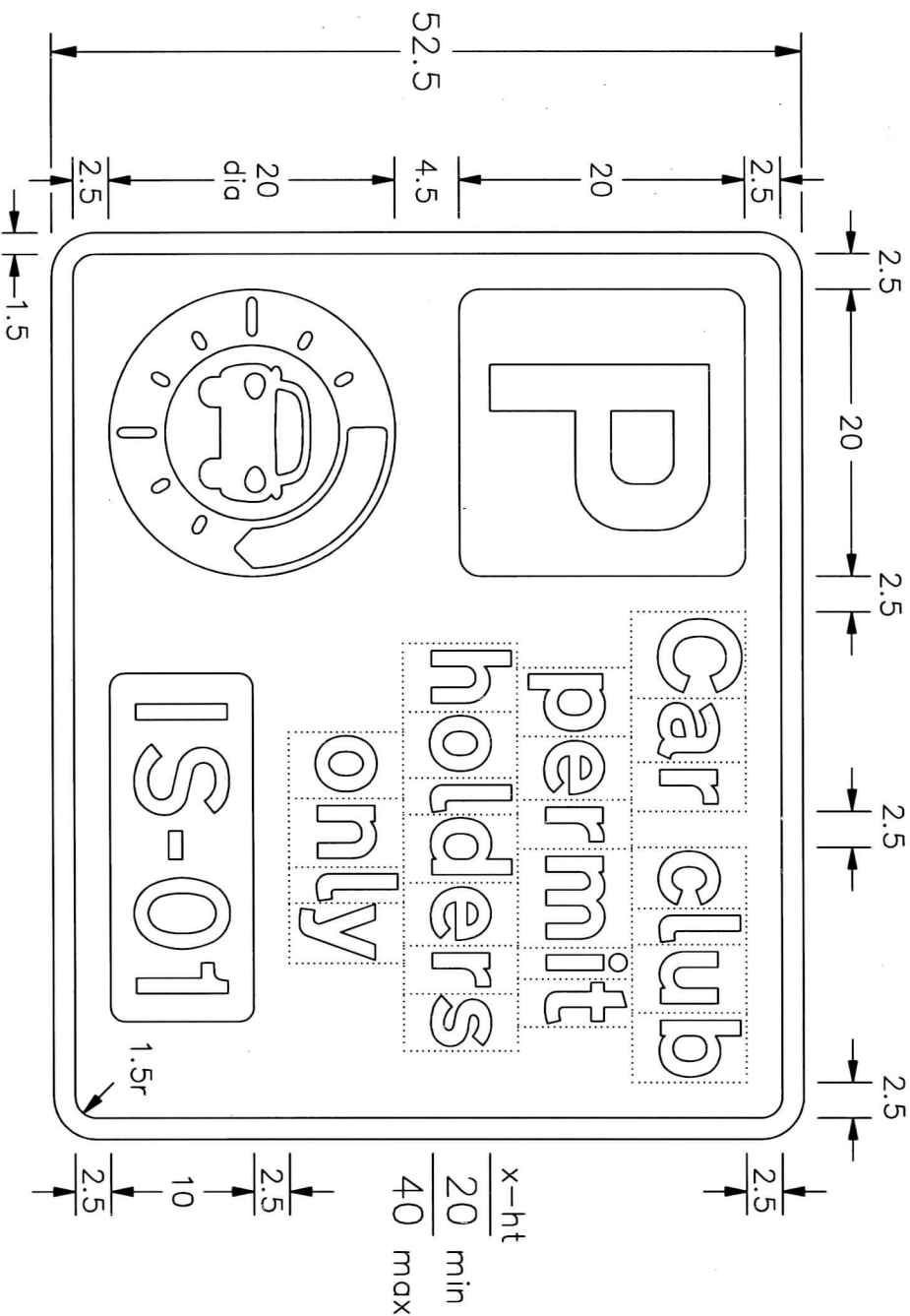
The provisions of Regulations 12 and 31 of the 2002 Regulations shall apply to the authorised marking C in the same manner as they apply to the road marking shown in diagram 1032 in Schedule 6 to those Regulations.

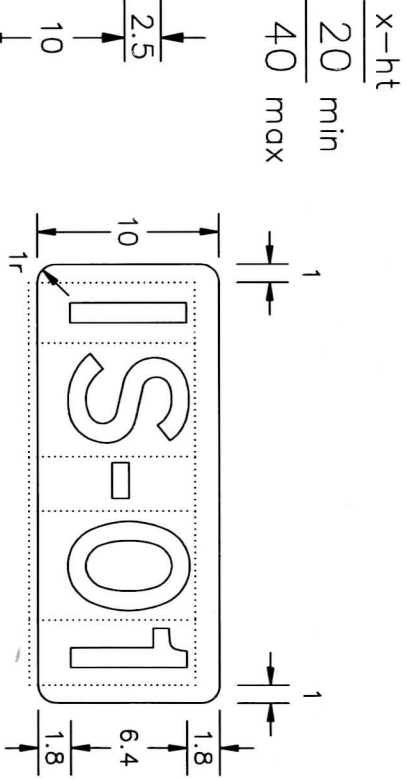


NOTES: 1. The legend is from the Transport Heavy alphabet at the x-heights shown.
