**ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65  
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of conditions attached to parking places for electric motorcycles in the City of Westminster, hereby:-

1. authorises the erection at appropriate sites within the city of Westminster of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown in the attached drawing numbered GT50/024/0017-1, save that references to a time limit, the time of the day, and day of the week, may be varied or omitted and an arrow pointing to left or right may be added; and
2. authorises the placing of traffic sign consisting of a road marking (herein after referred to as "the authorised marking") conforming as to size, colour and character with that shown in the attached drawing numbered GT50/024/0017-2; and
3. directs that the authorised sign shall only be used in conjunction with the authorised marking; and
4. directs that, it is a condition of this authorisation that the authorised sign and the authorised marking may be placed only to indicate the effect of a corresponding Traffic Order; and

5. directs that, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign and authorised marking at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and authorised marking on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of regulations 12, 18 and 19 of the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") shall apply to the authorised sign in the same manner as they apply to the sign shown in diagram 660.6 in Schedule 2 to those Regulations.


