

## ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984 and of all other powers enabling him in that behalf, for the purpose of informing road users of resident permit holder parking places in the West Common area of Harpenden, St Albans, hereby:-

- 1. authorises the erection at or within 5 metres of the sites marked with a red cross on the attached plan numbered GT50/127/0001-1 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown in the drawing numbered NP 434, save that a) the days of the week may be omitted or varied, b) the times of day may be omitted or varied and c) the permit identifier patch may be omitted or varied; and
- authorises the erection at or within 5 metres of the site marked with a blue cross on the said plan of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown in the drawing numbered GT50/127/0001-2; and
- 3. directs that the sign shown in diagram 660 or 660.3 in Schedule 2 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") may be erected in sufficient numbers to give adequate information to road users of the waiting restrictions in force within the said area; and

- 4. directs that, notwithstanding the provisions of Direction 24(1) of the Traffic Signs General Directions 2002 (Part II of SI 2002/3113), road markings to diagrams 1028.4, 1032 and 1033 in Schedule 6 to the 2002 Regulations need not be used in conjunction with the sign to diagram 660 or 660.3 in Schedule 2 to those Regulations in the said area; and
- directs that it is a condition of this authorisation that the authorised signs A and B may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and
- 6. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A and B and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign shown in diagram 660.3 in Schedule 2 to those Regulations.





