**ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of marking parking bays and loading bays on East Street, Horsham, West Sussex, hereby:-

1. authorises the use at the location indicated schematically at A on the attached plan numbered GT50/146/0002-1 of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking A") delineated with stone blocks and conforming as to colour and character to those markings shown in the attached set of photographs numbered GT50/146/0002-2 and in size to the markings shown in diagram 1028.3 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113 "the 2002 Regulations"), save that there shall be no legend; and
2. authorises the use at the locations indicated schematically at B on the said plan of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking B") delineated with stone blocks and conforming as to colour and character to those markings shown in the said set of photographs and in size to those markings shown in diagram 1032 in Schedule 6 to the 2002 Regulations, save that there shall be no legend; and
3. directs that notwithstanding the provisions of Direction 25(1) of the Traffic Signs General Directions (Part II of SI 2002/3113 "the 2002 Directions"), the authorised marking A shall only be placed in conjunction with a traffic sign to diagram 661A in Schedule 2 to the 2002 Regulations; and

4. directs that notwithstanding Direction 25(1) of the 2002 Directions, the authorised marking B shall be placed in conjunction with a traffic sign to diagram 660.4 or diagram 661A in Schedule 2 to the 2002 Regulations; and
5. directs without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the placing of the authorised markings A and B within the said areas shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised road markings A and B and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12 and 31 of the 2002 Regulations shall apply to the authorised road marking A in the same manner as they apply to the road marking shown in diagram 1028.3 in Schedule 2 to those Regulations.

The provisions of Regulations 12 and 31 of the 2002 Regulations shall apply to the authorised road marking B in the same manner as they apply to the road marking shown in diagram 1032 in Schedule 2 to those Regulations.

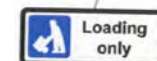
