**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of cashless parking, and pay and display parking, on roads for which Nottingham City Council is the highway authority, hereby:-

1. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as “the authorised sign A”) conforming as to size, colour and character with that shown on the attached drawing numbered GT50/117/0002-1, save that: the days, times and time limit may be varied; the direction of the arrow may be varied to point to the left (or the arrow may be omitted); the colour of the parking zone patch may be varied; the parking zone identification may be varied; and
2. authorises the erection at the said sites of a traffic sign (hereinafter referred to as “the authorised sign B”) conforming as to size, colour and character with that shown on the attached drawing numbered GT50/117/0002-2, save that: the days, times and time limit may be varied; an arrow may be added in the manner shown in diagram 661.2A in Schedule 2 to the Traffic Signs Regulations 2002 (Part I to SI 2002/3113 – “the 2002 Regulations”), the direction of the arrow may point to the left or to the right; a second arrow pointing in the opposite direction may be added; the legend "here" shall be omitted when an arrow has been added; the colour of the parking zone patch may be varied, and the parking zone identification may be varied; and

3. directs that, notwithstanding the provisions of Direction 24(1) of the Traffic Signs General Directions 2002 (Part II of SI 2002/3113, 'the 2002 Directions'), the authorised sign A shall be used in conjunction with the road markings shown in diagram 1017 and diagram 1019, in Schedule 6 to the 2002 Regulations; and,
4. directs that, notwithstanding the provisions of Direction 24(1) of the 2002 Directions, the authorised sign A shall be used in conjunction with and any of road markings shown in diagram 1028.3, diagram 1028.4, diagram 1032 and diagram 1033, where no legend appears, in Schedule 6 to the 2002 Regulations; and
5. directs that, notwithstanding the provisions of Direction 24(1) of the 2002 Directions, the authorised sign B shall be used in conjunction with any of the road markings shown in diagram 1028.4, diagram 1032 and diagram 1033, where no legend appears, in Schedule 6 to the 2002 Regulations; and
6. directs that it is a condition of this authorisation that the authorised sign A and the authorised sign B may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and
7. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign A and the authorised sign B, at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign A and the authorised sign B, and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provision of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign shown in diagram 639.1B in Schedule 2 to those Regulations.

The provision of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign shown in diagram 661.3A in Schedule 2 to those Regulations.

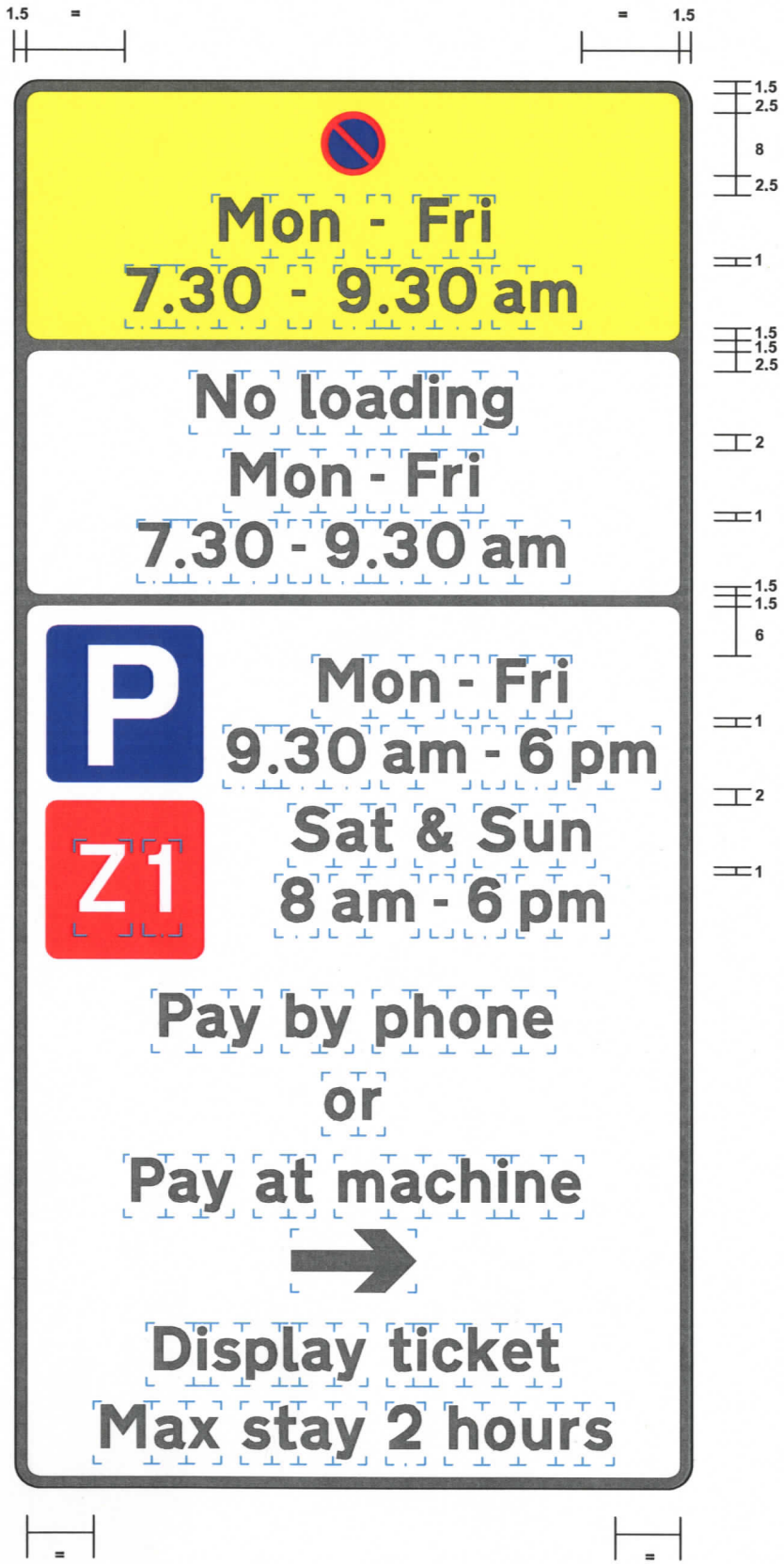
