



ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of mobile phone park and pay zones on roads for which the London Borough of Bexley is the traffic authority, hereby:-

- 1. authorises the erection at or in the vicinity of the sites marked A in the attached set of plans numbered GT50/072/0001-1 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown at A in the attached set of drawings numbered GT50/072/0001-2, save that (a) the telephone number and location code may be varied, (b) an arrow pointing to the left or the right as appropriate may be added and (c) the days of the week, times of day and the time limit for maximum stay may be varied or omitted; and
- 2. authorises the erection at or in the vicinity of the sites marked B in the said set of plans of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown at B in the said set of drawings, save that (a) the word "Resident" may be varied to "Business", (b) the telephone number and location code may be varied, (c) an arrow pointing to the left or the right as appropriate may be added and (d) the times of day, days of the week and time limit for maximum stay may be varied or omitted; and





- 3. directs that, notwithstanding the provisions of Direction 25 of the Traffic Signs General Directions 2002 (Part II of SI 2002/3113, "the 2002 Directions"), the authorised signs A and B may be used with the road marking shown in diagram 1028.4 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations"), save that the word "DOCTOR" shall be omitted; and
- directs that, notwithstanding the provisions of Direction 25 of the 2002 Directions, the authorised signs A and B may be used with the road marking shown in diagram 1032 in Schedule 6 to the 2002 Regulations; and
- directs that it is a condition of this authorisation that the authorised signs A and B may only be placed to indicate the effect of a corresponding Traffic Order; and
- 6. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the alteration of the authorised signs A and B and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.



GT50/072/0001

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised signs A and B in the same manner as they apply to the sign shown in diagram 660.7 in Schedule 2 to those Regulations.

This authorisation replaces the one dated 1 June 2011 under reference GT50/072/0001 which is hereby revoked.






