**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984 and of all other powers enabling him in that behalf, for the purpose of informing road users of the provision of parking at Wimbledon Bridge in the London Borough of Merton, hereby:-

1. authorises the erection at or within 5 metres the site shown with a red cross on the attached combined plan and sign drawing numbered GT50/090/0002-1 of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown at A on the said combined plan and sign drawing, save that:
 - (a) a reference to the time of day or the day of the week may be added; and
 - (b) the reference to the time limit may be varied or omitted; and
 - (c) the reference to the time within which return is permitted may be varied or omitted; and
 - (d) the direction of the arrow may be varied with the arrow pointing horizontally to the left or to the right; and
 - (e) the arrow may be omitted; and
2. directs, that it is a condition of this authorisation that the authorised sign may only be placed to indicate the effect of a corresponding Traffic Regulation Order; and



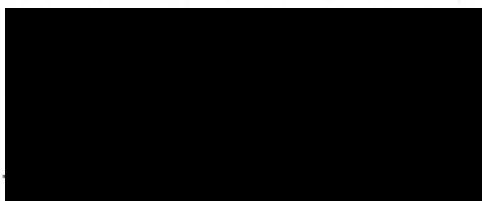

3. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the placing of the authorised sign at or near the said site shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

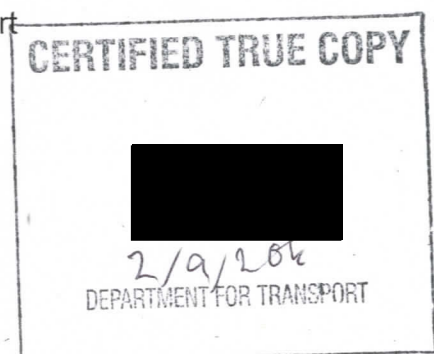
The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign in the same manner as they apply to the sign to diagram 661.1 in Schedule 2 to those Regulations.
