**ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of the temporary suspension of parking places in Brighton and Hove, hereby:-

1. authorises the erection on roads for which the Brighton and Hove City Council is traffic authority of a traffic sign (hereinafter referred as "the authorised sign") conforming as to size, colour and character with the sign shown on the attached drawing numbered GT50/0014/0004-1;
and
2. directs that (i) information regarding the time of day, date or dates, (with the year omitted) and location of the suspended parking place or places shall be shown on the front of the authorised sign; and (ii) information regarding the type of parking place, the reason for the parking suspension, or an identifying reference may be shown on the authorised sign; and
3. directs that this sign may not be erected at the same location for longer than six months; and



4. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign at or near the said site shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

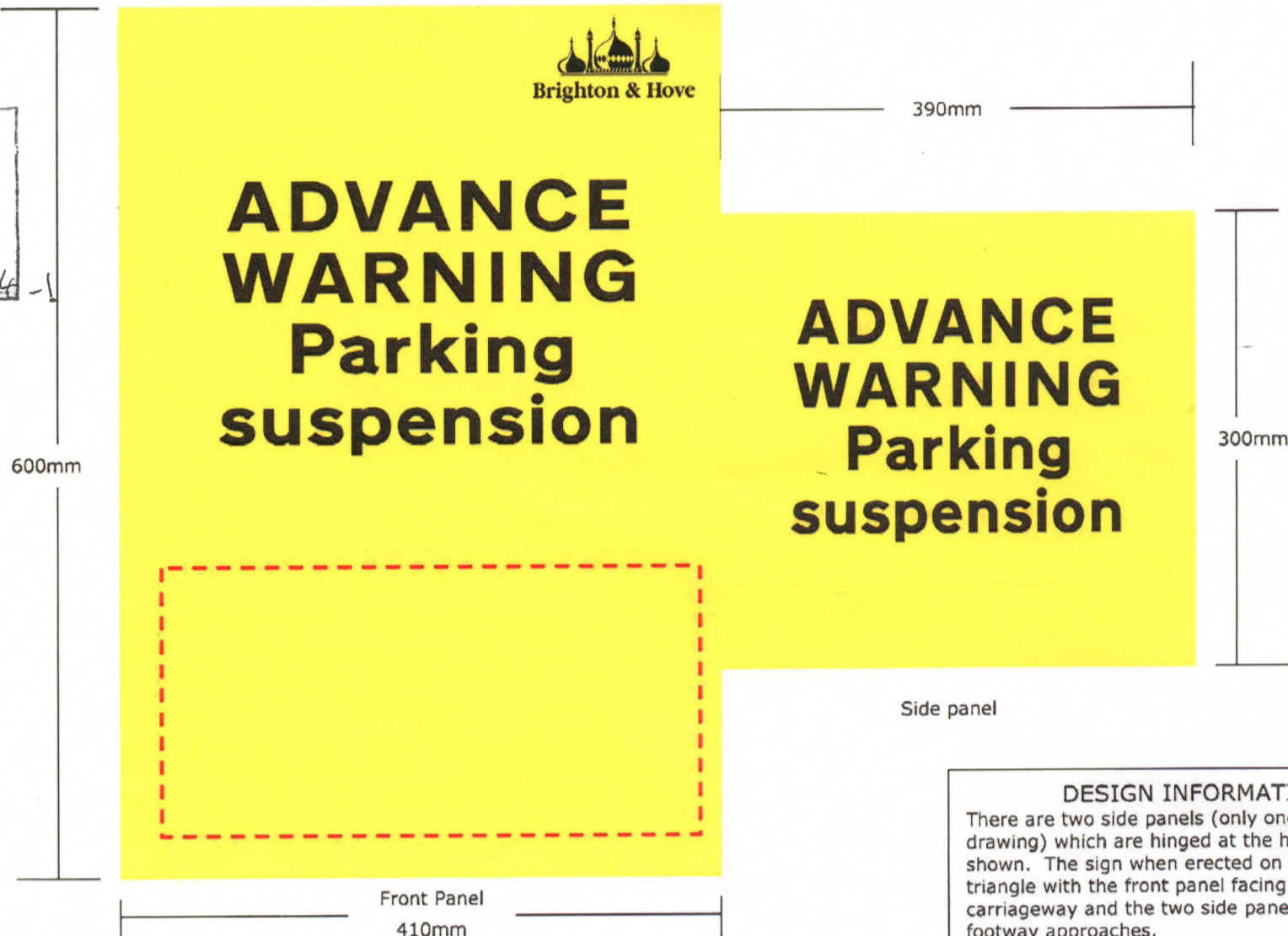

Side panel

DESIGN INFORMATION

There are two side panels (only one shown on drawing) which are hinged at the hinge points shown. The sign when erected on a post form a triangle with the front panel facing the edge of carriageway and the two side panels facing the footway approaches.
