



ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984 and of all other powers enabling him in that behalf, for the purpose of informing road users of a Restricted Zone in New Street (West Bromwich Ringway), in Sandwell, hereby:-

- 1. authorises the erection at or within 5 metres of the sites marked schematically on the attached plan numbered GT50/152/0005-1 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown on the attached drawing numbered NP663.2 save that the reference to the time of day or the day of the week may be varied or omitted; and
- 2. authorises the erection within the area highlighted in blue on the said plan of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown on the attached drawing numbered NP637.4, save that the reference to the time of day or the day of the week may be varied or omitted; and
- authorises the erection at or within 5 metres of the sites marked schematically on the said plan of a traffic sign (hereinafter referred to as "the authorised sign C") conforming as to size, colour and character with that shown on the attached drawing numbered NP664.1; and





- 4. directs that the authorised sign B shall be erected in sufficient numbers to give adequate information to road users of the waiting restrictions in force in the said highlighted area; and
- directs, that it is a condition of this authorisation that the authorised signs A, B and C shall only be placed to indicate the effect of a corresponding Traffic Regulation Order; and
- 6. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the placing of the authorised signs A, B and C at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A, B and C and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") shall apply to the authorised sign A in the same manner as they apply to the sign shown in diagram 663 in Schedule 2 to those Regulations.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign shown in diagram 637.2 in Schedule 2 to those Regulations.





