

## ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of the conditions of use of a bus lane on Haven Green in the London Borough of Ealing, hereby:-

- authorises the erection at the site on the said road marked A on the attached plan numbered GT50/077/0003-1 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown in the attached drawing numbered NP 958.6, save that a lower panel may be added in the same colours as in diagram 961 in Schedule 5 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations"); and
- 2. authorises the erection at the site on the said road marked B on the said plan of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown in the attached drawing numbered NP 959.5, save that a lower panel may be added in the same colours as in diagram 961 in Schedule 5 to the 2002 Regulations; and
- directs that the authorised sign A shall be used with the road marking in diagram 1010 (when laid diagonally) in Schedule 6 to the 2002 Regulations; and



- 4. directs that, notwithstanding the provisions of Direction 18(3) of the Traffic Signs General Directions 2002 (Part II of SI 2002/3113, "the 2002 Directions"), the authorised sign B may be used with the road marking shown in diagram 1049 in Schedule 6 to the 2002 Regulations; and
- directs that it is a condition of this authorisation that the authorised signs A and B may be placed only to indicate the effect of a corresponding Traffic Order; and
- 6. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A and B and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect; and

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign to diagram 958 in Schedule 5 to those Regulations.





The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign to diagram 959 in Schedule 5 to those Regulations.


