**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road user of part-time speed limits (either advisory or mandatory) at sites in the Metropolitan Borough of Solihull, hereby:-

1. authorises the erection at appropriate sites on roads for which Solihull Metropolitan Borough Council is the traffic authority of a traffic sign (hereinafter referred to as “the authorised sign A”) conforming as to size, colour and character with that shown at A on the attached drawing numbered GT50/143/0003-1; and
2. authorises the erection at appropriate sites on roads for which Solihull Metropolitan Borough Council is the traffic authority of a traffic sign (hereinafter referred to as “the authorised sign B”) conforming as to size, colour and character with that shown at B on the attached drawing numbered GT50/143/0003-2; and
3. directs that the authorised signs A and B must not be erected at the same site; and
4. directs that it is a condition of this authorisation that the authorised sign B may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and
5. directs that the authorised signs A and B must be used above the signal to diagram 4004 in Schedule 9 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, “the 2002 Regulations”); and

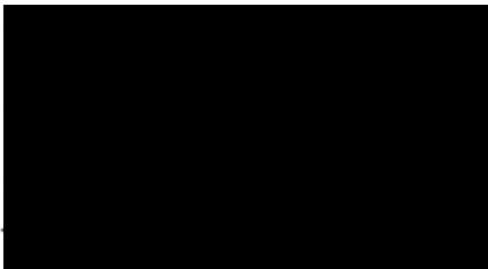
6. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A and B and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign to diagram 545 in Schedule 2 to those Regulations.

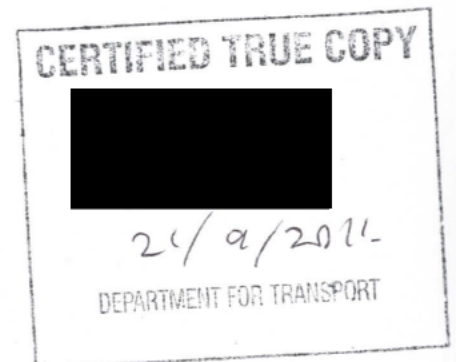
The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign to diagram 670 in Schedule 2 to those Regulations.
