



## ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984 and of all other powers enabling her in that behalf, for the purpose of informing road users of a Restricted Zone in Dennis Way, Slough, hereby:-

- authorises the erection at or within 5 metres of the sites marked schematically on the attached plan numbered GT50/170/0005-1 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that referenced "A" in the attached set of drawings numbered GT50/170/0005-2 save that a reference to the time of day or the day of the week may be varied or omitted; and
- 2. authorises the erection at or within 5 metres of the sites marked schematically on the said plan of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that referenced "B" in the said set of drawings, save that a reference to the time of day or the day of the week may be varied or omitted; and
- 3. authorises the erection at or within 5 metres of the sites marked schematically on the said plan of a traffic sign (hereinafter referred to as "the authorised sign C") conforming as to size, colour and character with that referenced "C" in the said set of drawings; and





- 4. directs that, notwithstanding the provisions of Direction 25 of the Traffic Signs General Directions 2002 (Part II of SI 2002/3113, "the 2002 Directions"), the authorised signs A, B and C may be used with any of the road markings to diagrams 1028.3, 1028.4, 1032 and 1033 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations"), save that there shall be no legend; and
- directs, that it is a condition of this authorisation that the authorised signs A, B and C shall only be placed to indicate the effect of a corresponding Traffic Regulation Order; and
- 6. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the placing of the authorised signs A, B and C at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A, B and C and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") shall apply to the authorised sign A in the same manner as they apply to the sign to diagram 663 in Schedule 2 to those Regulations.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign to diagram 637.2 in Schedule 2 to those Regulations.



## GT50/170/0005

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign C in the same manner as they apply to the sign to diagram 664 in Schedule 2 to those Regulations.
