

ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS


The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984 and of all other powers enabling her in that behalf, for the purpose of informing road users of parking places for Car Club members and Electric Vehicle Recharging points in Newcastle upon Tyne, hereby:-

- authorises the erection at appropriate sites on roads for which Newcastle upon Tyne City Council is the traffic authority of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown on the attached drawing numbered P 660.8, save that:
 - (a) a reference to the time limit, time within which return is prohibited,time of the day or the day of the week may be added; and
 - (b) the borough arms and name may be added; and
 - (c) a permit parking code identifier patch may added or varied as appropriate; and
- authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown on the attached drawing numbered P 660.9, save that:
 - (a) a reference to the time limit, time within which return is prohibited, time of the day or the day of the week may be added, varied or omitted as appropriate; and
 - (b) the borough arms and name may be added; and






- (c) a permit parking code identifier patch may added or varied as appropriate; and
- (d) the legend "Permit holders only" may be omitted; and
- 3. authorises the placing at appropriate sites on the said roads of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking A") conforming as to size, colour and character with that to diagram 1028.3 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") except that the word "DISABLED" shall be replaced by "CAR CLUB"; and
- 4. authorises the placing at appropriate sites on the said roads of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking B") conforming as to size, colour and character with that to diagram 1028.4 in Schedule 6 to the 2002 Regulations except that the word "DOCTOR" shall be replaced by the legend "CAR CLUB"; and
- 5. authorises the placing at appropriate sites on the said roads of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking C") conforming as to size, colour and character with that shown at diagram 1032 in Schedule 6 to the 2002 Regulations except that the legend "CAR CLUB" shall be added in the manner shown in diagram 1028.4 in those Regulations; and;





- 6. authorises the placing at appropriate sites on the said roads of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking D") conforming as to size, colour and character with that to diagram 1028.3 in Schedule 6 to the 2002 Regulations except that the word "DISABLED" shall be replaced by the legend "ELECTRIC VEHICLES ONLY" or "ELECTRIC VEHICLES" or "ELECTRIC VEHS ONLY" or "ELECTRIC VEHS"; and
- 7. authorises the placing at appropriate sites on the said roads of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking E") conforming as to size, colour and character with that to diagram 1028.4 in Schedule 6 to the 2002 Regulations except that the word "DOCTOR" shall be replaced by the legend "ELECTRIC VEHICLES ONLY" or "ELECTRIC VEHICLES" or "ELECTRIC VEHS ONLY" or "ELECTRIC VEHS"; and
- 8. authorises the placing at appropriate sites on the said roads of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking F") conforming as to size, colour and character with that shown at diagram 1032 in the 2002 Regulations except that the legend "ELECTRIC VEHICLES ONLY" or "ELECTRIC VEHICLES" or "ELECTRIC VEHS ONLY" or "ELECTRIC VEHS" shall be added in the manner shown in diagram 1028.4 in Schedule 6 to those Regulations; and;
- 9. directs that the authorised markings A, B and C may be used only with the authorised sign A; and
- 10. directs that the authorised markings D, E and F may only be used with the authorised sign B, and






- 11. directs, that it is a condition of this authorisation that the authorised signs A and B and the authorised markings A, B, C, D, E and F shall only be placed to indicate the effect of a corresponding Traffic Regulation Order; and
- 12. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the placing of the authorised signs A and B and the authorised markings A, B C, D, E, and F at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A and B and the authorised markings A, B C, D, E and F and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised signs A and B in the same manner as they apply to the sign to diagram 660.3 in Schedule 2 to those Regulations.

The provisions of Regulations 12 and 31 of the 2002 Regulations shall apply to the authorised marking A and D in the same manner as they apply to the road marking to diagram 1028.3 in Schedule 6 to those Regulations.

The provisions of Regulations 12 and 31 of the 2002 Regulations shall apply to the authorised marking B and E in the same manner as they apply to the road marking to diagram 1028.4 in Schedule 6 to those Regulations.





The provisions of Regulations 12 and 31 of the 2002 Regulations shall apply to the authorised marking C and F in the same manner as they apply to the road marking to diagram 1032 in Schedule 6 to those Regulations.






