



## ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984 and of all other powers enabling her in that behalf, for the purpose of informing road users of shared use loading and parking bays in Victoria Road, Surbiton, hereby:-

- 1. authorises the erection at or within 5 metres of the sites shown schematically and referenced "Sign no. 1" on the attached plan numbered GT50/155/0008-1 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown as "Sign Type 1" in the attached set of drawings numbered GT50/155/0008-2 save that references to a time limit, day of the week, time of day or time within which return is prohibited may be varied or omitted as appropriate; and
- 2. authorises the erection at or within 5 metres of the site shown schematically and referenced "Sign no 2" on the said plan of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown as "Sign Type 2" in the said set of drawings save that references to a time limit, day of the week, time of day or time within which return is prohibited may be varied or omitted as appropriate; and
- directs that, notwithstanding the provisions of direction 25(1) of the Traffic Signs General Directions 2002 (Part II of SI 2002/3113) the authorised signs A and B may be placed in conjunction with the road markings to diagram 1028.4 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations"); and



- directs that it is a condition of this authorisation that the authorised signs A and B may be placed only to indicate the effect of a corresponding Traffic Order; and
- 5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the placing of the authorised signs A and B at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and the authorised marking and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") shall apply to the authorised signs A and B in the same manner as they apply to the sign shown in diagram 660.4 in Schedule 2 to those Regulations.


