


## ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling her in that behalf, for the purpose of informing road users of parking places paid by phone or for permit or card holders on roads for which Nottingham City Council is the traffic authority, hereby:-

- 1. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown at A in the attached set of drawings numbered GT50/117/0014-1 save that (a) the indication of a telephone number and/or a location code may be added, (b) the permit identifier, card identifier or zone number may be varied or omitted; (c) references to a time limit, the time of the day, the day of the week, or the time within which return is prohibited, may be added, varied or omitted (d) the zone identifier patch may be coloured to denote the zone and may be placed directly under the "P" symbol; and
- 2. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown at B in the said set of drawings save that (a) the indication of a telephone number and/or a location code may be added, (b) the card identifier or zone number may be varied or omitted; (c) references to a time limit, the time of the day, the day of the week, or tor the time within which return is prohibited, may be added, varied or omitted and (d) the zone identifier patch may be coloured to denote the zone and may be placed directly under the "P" symbol; and




- 3. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign C") conforming as to size, colour and character with that shown at C in the said set of drawings save that (a) the indication of a telephone number and/or a location code may be added, (b) the card identifier or zone number may be varied or omitted; (c) an arrow pointing horizontally to the left or the right as appropriate may be added; (d) references to a time limit, the time of the day, the day of the week, or the time within which return is prohibited, may be added, varied or omitted and (e) the zone identifier patch may be coloured to denote the zone and may be placed directly under the "P" symbol; and
- 4. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign D") conforming as to size, colour and character with that shown at D in the said set of drawings save that (a)the indication of a telephone number and/or a location code may be added, (b) the card identifier or zone number may be varied or omitted; (c) the legend "Pay here" may be varied to "Pay at machine opposite" (d) references to a time limit, the time of the day, the day of the week, or the time within which return is prohibited, may be added, varied or omitted and (e) the zone identifier patch may be coloured to denote the zone and may be placed directly under the "P" symbol; and
- 5. directs that, notwithstanding the provisions of Direction 25 of the Traffic Signs General Directions 2002 (Part II of SI 2002/3113, "the 2002 Directions"), the authorised signs A, B, C and D may be used with the road marking shown in diagram 1028.4 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations"), save that the word "DOCTOR" shall be omitted; and





- directs that, notwithstanding the provisions of Direction 25 of the 2002
  Directions, the authorised signs A, B, C and D may be used with the
  road markings shown in diagram 1032 or 1033 in Schedule 6 to the
  2002 Regulations; and
- directs that it is a condition of this authorisation that the authorised signs A, B, C and D may only be placed to indicate the effect of a corresponding Traffic Regulation Order; and
- 8. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A, B, C and D at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the alteration of the authorised signs A, B, C and D and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.





The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised signs A, B, C and D in the same manner as they apply to the sign shown in diagram 660.7 in Schedule 2 to those Regulations.
