ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of powers conferred on her by Sections 64(1) and (2) and 65(1) of the Road Traffic Regulation Act 1984 (1) and of all other powers enabling her in that behalf, hereby gives the authorisation contained in paragraphs 2 and 3 of this Instrument and gives the directions contained in paragraph 4 of this Instrument.

1. In this Instrument—

"authorised sign" means a traffic sign whose erection is authorised by paragraph 2(1) or (2),

"red route controls" means prohibitions or restrictions imposed by or under an order or notice under the Road Traffic Regulation Act 1984 on any class of traffic on road shown in the attached plan GT50/152/0009-1; and

- 2. (1) Subject to paragraph 3 below, the Secretary of State hereby authorises the erection at sites marked with an orange cross on the said plan of a traffic sign of the size, colour and character shown in the attached drawing numbered GT50/152/0009-2; and
 - (2) Subject to paragraph 3 below, the Secretary of State hereby authorises the erection at site marked with a green cross on the said plan of a traffic sign of the size, colour and character shown in the attached drawing numbered GT50/152/0009-3:

for the purpose of conveying to traffic the effect of red route controls applying to that road; and

- (3) Where it is specified in a drawing that part of a sign is to be of a particular colour, the colour of that part shall be as shown in the notes to the appropriate drawing
- 3. (1) The provisions of Regulation 12(10) (variation of dimensions) of The Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") shall apply to the dimensions specified in the said set of drawings in relation to the authorised signs as they apply to dimensions specified in those Regulations.
 - (2) The provisions of Regulations 18 and 19 of the 2002 Regulations (illumination of signs) shall apply to the authorised signs as they apply to the sign shown in diagram 650.1 in Schedule 2 to those Regulations.

(3) Any indication given by authorised sign of a time of day, day of the week or class of traffic may be varied so as to correspond with the Red Route controls whose effect the sign has been placed to indicate.

(4) Where—

- a) overall dimensions are given for an authorised sign in a drawing in the said set of drawings; and
- b) the legend on that sign is varied in accordance with sub-paragraph (3) above,

the overall dimensions or the number of lines occupied by the legend, or both, may be varied so far as necessary to give effect to the variation of the legend.

- 4. The Secretary of State hereby directs that—
 - (1) the authorised signs may be erected only in conjunction with an authorised road marking authorised in a document dated 9 May 2012 under reference GT50/190/0001; and
 - (2) the authorised road marking as described in sub-paragraph (1) may be placed only in conjunction with the authorised signs; and
 - (3) without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs the authorisation shall, without prejudice to the giving of any further authorisation or direction and on that day the said, cease to have effect.

This authorisation is in addition to one dated 9 May 2012 under reference GT50/190/0001 which replaces one dated 2 October 2007 under reference GT46/61/04 now revoked.




