**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling her in that behalf, for the purpose of informing road users of parking places including some partially and wholly on the footway on roads for which the London Borough Of Waltham Forest is the traffic authority, hereby:-

1. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown as "Sign A" on the attached drawing numbered GT50/097/0014-1, save that :-
 - i) the reference to the time of the day or the day of the week may be varied or omitted as appropriate; and
 - ii) references to time limits or the time within which return is prohibited may be varied or omitted; and
 - iii) an arrow pointing horizontally to the left or right may be added; and
 - iv) The "P" parking symbol may be varied to the symbols for parking wholly or partially on the footway, as shown on the part of the said drawing labelled "Example of variation for parking on the footway, with alternative symbols"; and

2. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown as "Sign B" on the said drawing, save that the sign may be varied in the same manner as the authorised sign A; and
3. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign C") conforming as to size, colour and character with that shown as "Sign C" on the said drawing, save that the sign may be varied in the same manner as the authorised sign A; and
4. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign D") conforming as to size, colour and character with that shown as "Sign D" on the said drawing, the sign may be varied in the same manner as the authorised sign A and, additionally, the permit code identifier may be varied; and
5. directs that, notwithstanding the provisions of Direction 25(1) of the Traffic Signs General Directions 2002 (Part II of SI 2002/3113) the authorised signs A, B, C and D shall only be erected in conjunction with the road marking to diagram 1028.4 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations"); and
6. directs that it is a condition of this authorisation that the authorised signs A, B, C and D may be placed only to indicate the effect of a corresponding Traffic Order; and

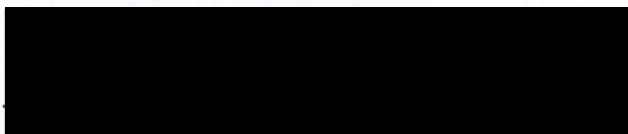
7. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A, B, C and D at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A, B, C and D and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised signs A and D in the same manner as they apply to the sign to diagram 660.6 in Schedule 2 to those Regulations.

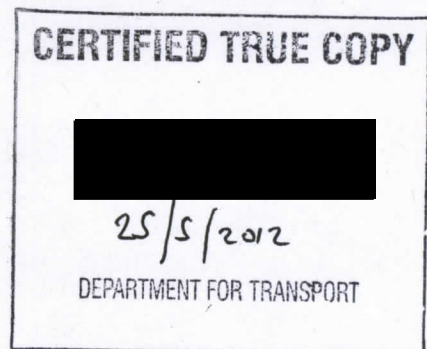
The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised signs B and C in the same manner as they apply to the sign to diagram 639.1B in Schedule 2 to those Regulations as amended by the Traffic Signs (Amendment) (No.2) Regulations 2011 (Part 1 of SI 2011/3041).

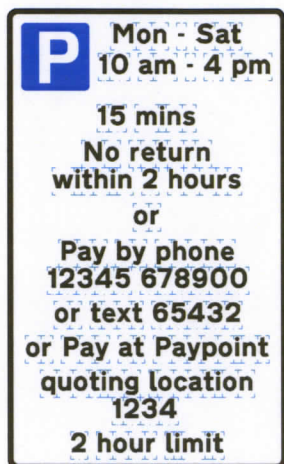

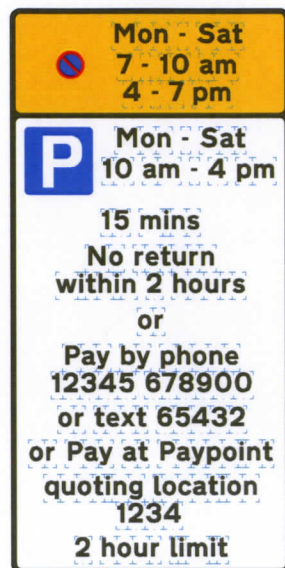

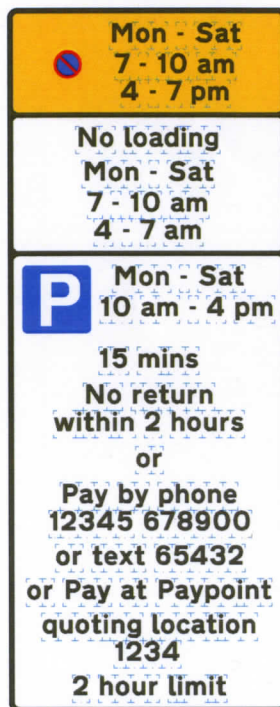

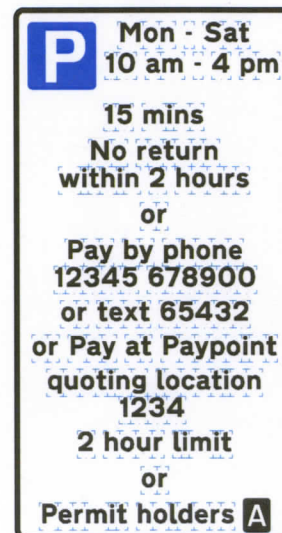

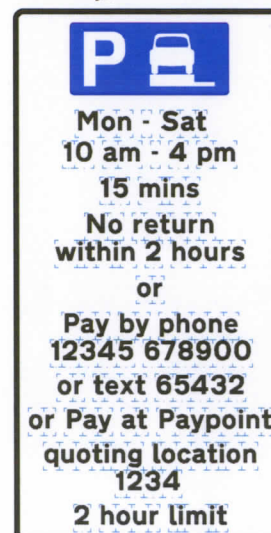

Proposed variations

- (i) References to the restriction days and times may be varied or omitted;
- (ii) References to the time limits and the time within which return is prohibited may be varied or omitted;
- (iii) An arrow pointing horizontally to the left or right may be added.
- (iv) Letters and numbers indicating a parking zone or permit may be added or varied.
- (v) Symbols for parking places wholly or partially on the footway may be used, instead of the 'P' parking place symbol, at appropriate places.
