



ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling her in that behalf, for the purpose of informing road users of temporary parking restrictions on roads in the London Borough of Newham associated with Olympic or Paralympic venues, hereby:-

- authorises the erection on the said roads of a traffic sign conforming as
 to size, colour and character with that shown in the attached drawing
 numbered GT50/091/0010-1 (hereinafter referred to as "the authorised
 sign A"), save that the code identifier patch and references to the time
 of day or day of the week may be varied or omitted; and
- authorises the erection on the said roads of a traffic sign conforming as
 to size, colour and character with that shown in the attached drawing
 numbered GT50/091/0010-2 (hereinafter referred to as "the authorised
 sign B"), save that the code identifier patch and references to the time
 of day or day of the week may be varied or omitted; and
- directs that it is a condition of this authorisation that the authorised signs A and B shall be erected only to indicate the effect of a corresponding Traffic Order; and




- 4. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A and B and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect; and
- 5. directs that, notwithstanding anything to the contrary contained in the preceding paragraph, the authorised signs A and B shall be retained no later than 31 October 2012.

The provisions of Regulations 12, 18 and 19 of the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") shall apply to the authorised sign A in the same manner as they apply to the sign to diagram 663 in Schedule 2 to those Regulations.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign to diagram 660 in Schedule 2 to those Regulations as amended by the Traffic Signs (Amendment) (No.2) Regulations 2011 (Part 1 of SI 2011/3041).


