

ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling her in that behalf, for the purpose of informing road users of a pedestrian zone without loading restrictions on roads for which the City of Westminster is the traffic authority, hereby:-

- authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/024/0044-1, save that:
- (a) a reference to the time of day, the day of the week or the month of the year may be added, varied or omitted; and
- (b) the sign to diagram 617 in Schedule 2 to The Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") incorporated in the authorised sign may be varied to a sign to diagram 619 in Schedule 2 to the said Regulations (in which case the legend "No vehicles" must be omitted); and
- directs that it is a condition of this authorisation that the authorised sign may only be placed to indicate the effect of a corresponding Traffic Order; and



3. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the alteration of the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign in the same manner as they apply to the sign to diagram 618.3 in Schedule 2 to those Regulations.

This authorisation replaces the earlier one dated 27 January 2012 under reference GT50/024/0020 which is hereby revoked.
