

ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users that they are entering the Nidderdale Area of Outstanding Natural Beauty in North Yorkshire, hereby:-

- authorises the erection within the vicinity of the sites marked with a black cross in the attached set of plans numbered GT50/113/0009-1 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with the sign shown at A in the attached set of drawings numbered GT50/113/0009-2; and
- authorises the erection within the vicinity of the site marked with a green cross in the said set of plans of a traffic sign (hereinafter referred to as "the authorised sign B") confirming as to size, colour and character with the sign shown at B in the said set of drawings; and
- directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.



The provisions of Regulations 12, 18 and 19 of the Traffic Signs Regulations 2002 (Part I of SI 2002/3113) shall apply to the authorised signs A and B in the same manner as they apply to the sign shown in diagram 2403.1 in Schedule 7 to those Regulations.

This authorisation replaces the one issued by this office under reference GT46/12/24 on 3 March 2006 which is hereby revoked.


