## ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of parking restrictions on roads in the City of Leeds during events at Headingly Carnegie Stadium, hereby:-

 authorises the erection at the sites shown schematically in the attached set of plans numbered GT50/065/0020-1 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with the sign shown at "SIGN A" in the attached drawing numbered GT50/065/0020-2, save that;

i) in the middle panel, references to the time of day may be added; and

ii) in the middle panel, a permit holder identifier symbol may be added; and;

iii) in the bottom panel, references to a date and month of the year may be varied; and

 authorises the erection at the sites shown schematically in the said set of plans of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with the sign shown at "SIGN B" in the said drawing, save that;

i) in the middle panel, references to the time of day may be varied and references to days of the week may be added; and

ii) in the middle panel, references to time limits or time within which return is prohibited may be varied; and

iii) in the bottom panel references to a date and month of the year may be varied; and



 authorises the erection at the sites shown schematically in the said set of plans of a traffic sign (hereinafter referred to as "the authorised sign C") conforming as to size, colour and character with the sign shown at "SIGN C" in the said drawing, save that;

> i) in either bottom panel of the top two signs, references to the time of day, day of the week, time limit or time within which return is prohibited, may be varied or added; as appropriate and

ii) in the bottom panel of the right-hand sign, a permit holder identifier symbol may be added; and;

iii) in the separate lower plate, references to a date and month of the year may be varied; and

4. authorises the erection at the sites shown schematically in the said set of plans of a traffic sign (hereinafter referred to as "the authorised sign D") conforming as to size, colour and character with the sign shown at "SIGN D in the said drawing, save that;

i) in the middle panel, references to the time of day or day of the week or time limit may be varied; and

ii) in the bottom panel, references to a date and month of the year may be varied; and

 directs that, notwithstanding the provisions of Direction 25 of the Traffic Signs General Directions 2002 (Part II of S.I. 2002/3113, "the 2002 Directions"), the authorised signs A, B, C and D may be used with the road marking shown in diagram 1028.4 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of S.I. 2002/3113, "the 2002 Regulations"), save that the word "DOCTOR" shall be omitted; and




- directs that, notwithstanding the provisions of Direction 25 of the 2002 Directions, the authorised sign D may be used with the road marking shown in diagram 1033 in Schedule 6 to the 2002 Regulations; and
- directs that it is a condition of this authorisation that the authorised signs A, B, C and D may only be placed to indicate the effect of a corresponding Traffic Regulation Order; and
- 8. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A, B, C and D at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the alteration or removal of the authorised signs A, B, C and D and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.




