## ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of parking places for diplomatic vehicles on roads for which Birmingham City Council is the traffic authority, hereby:-

- authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/006/0016-1; and
- 2. authorises the placing on the carriageway adjacent to the authorised sign of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/006/0016-2 save that the legend "DIPLOMATIC VEHICLES" shall be shown in the same manner as the word "DISABLED" in diagram 1028.3 in Schedule 6 of the Traffic Signs Regulations 2002 (SI 2002/3113, "the 2002 Regulations"); and
- 3. directs that the authorised marking shall only be used in conjunction with the authorised sign; and
- directs that it is a condition of this authorisation that the authorised sign and authorised marking may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and



5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign and placing of the authorised marking at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given to the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign or authorised marking and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign in the same manner as they apply to the sign shown in diagram 660 in Schedule 2 to those Regulations.

The provisions of Regulations 12 and 31 of the 2002 Regulations shall apply to the authorised marking in the same manner as they apply to the road marking shown in diagram 1028.3 in Schedule 6 to those Regulations.
