



**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984 and of all other powers enabling him in that behalf, for the purpose of warning drivers of motorcycle tests ahead, hereby:-

1. authorises the erection at suitable locations on roads for which Telford & Wrekin Council is the traffic authority, of a traffic sign (hereinafter referred to as "the authorised sign") comprising of a red warning triangle and a supplementary plate conforming as to size, colour and character with the sign shown on the attached drawing numbered NP 950.2; and
2. directs that, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the placing of the authorised sign at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

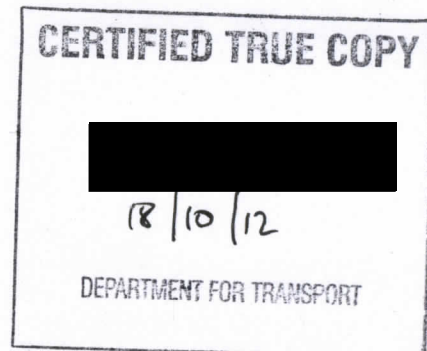
The provisions of Regulations 12, 18 and 19 of the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") shall apply to the authorised sign in the same manner as they apply to the sign to diagram 950 in Schedule 5 to those Regulations.

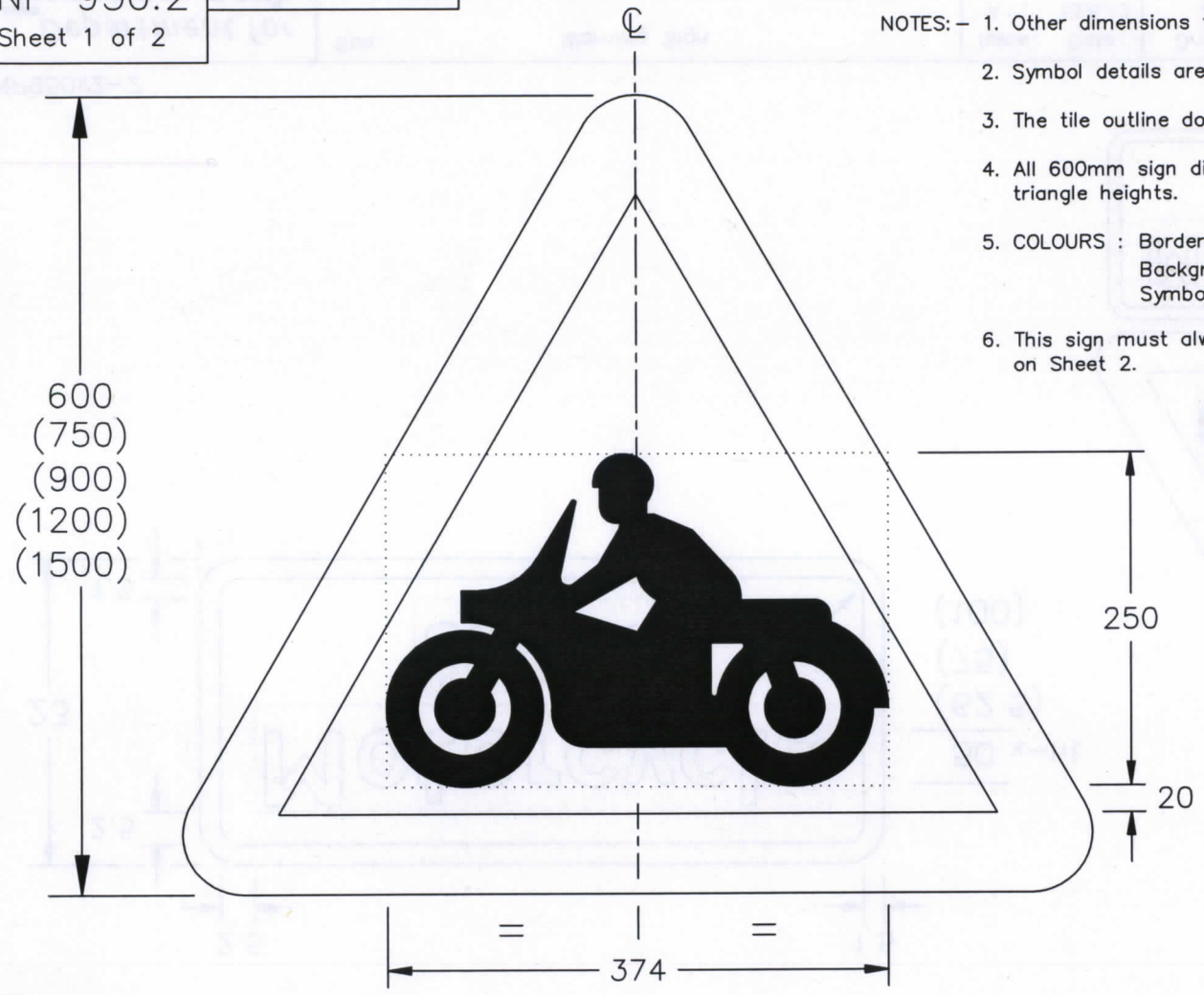

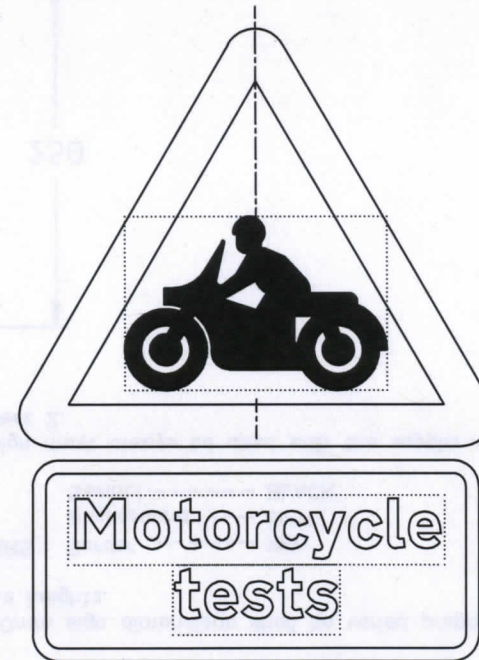
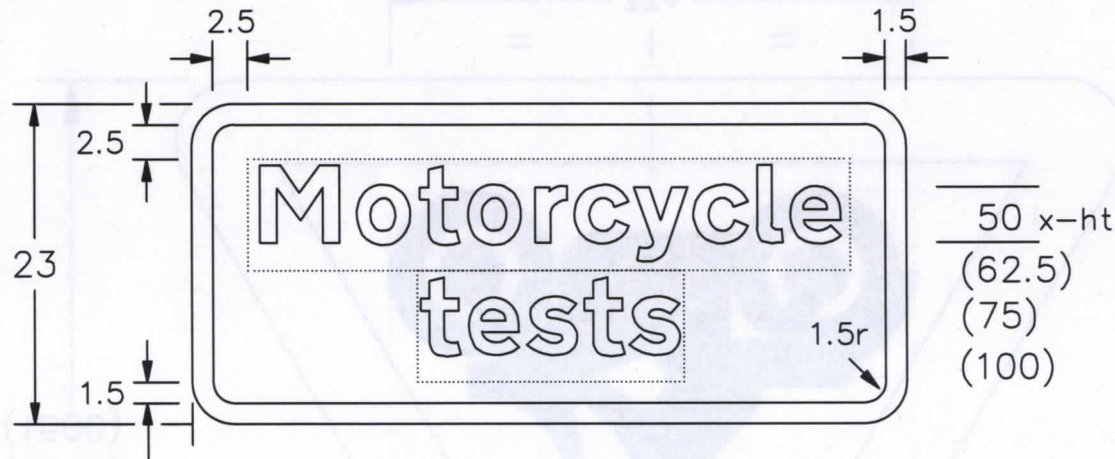
