

ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984 and of all other powers enabling him in that behalf, for the purpose of informing road users of disabled parking bays in Exeter city centre, Exeter, Devon, hereby:-

- 1. authorises the erection at suitable locations within the area highlighted in red shading on the attached plan numbered GT50/035/0036-1 of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/035/0036-2 save that references to the time of day or the time limit may be varied or omitted and a reference to day of the week may be added as appropriate; and
- directs that, notwithstanding the provisions of Direction 25(1) of the Traffic Signs General Directions 2002 (Part II of SI 2002/3113) the authorised sign may be placed in conjunction with the road markings to diagrams 1028.3, 1032 and 1033 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations"); and
- directs that it is a condition of this authorisation that the authorised sign may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and



4. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the placing of the authorised sign at or near the said site shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and the authorised marking and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign in the same manner as they apply to the sign shown in diagram 661A in Schedule 2 to those Regulations.


