



ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65

AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of parking conditions at appropriate sites on roads for which Bournemouth Borough Council is the traffic authority, hereby:-

1. authorises the erection at the said sites of a traffic sign (hereinafter referred to as “the authorised sign”) conforming as to size, colour and character with that shown on the attached drawing numbered GT50/011/0010-1 of a traffic sign (hereinafter referred to as the “the authorised sign”) save that (i) a reference to the time limit, time of day, day of the week or time within which return is prohibited may be varied or omitted; and (ii) the direction of the arrow may be varied with the arrow pointing horizontally to the left or to the right; and
2. directs that, notwithstanding the provision of Direction 25 (1) of the Traffic Signs General Directions 2002 (Part II of SI 2002/3113), the authorised sign may be used with road markings shown in diagrams 1028.3, 1032 and 1033 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, “the 2002 Regulations”); and
3. directs that it is a condition of this authorisation that the authorised sign may only be placed to indicate the effect of a corresponding Traffic Regulation Order; and

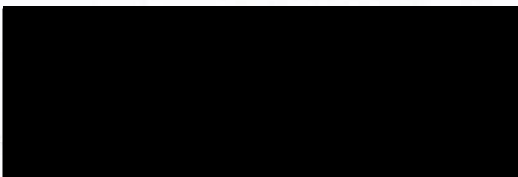

4. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign in the same manner as they apply to the sign to diagram 661A in Schedule 2 to those Regulations
