

ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of parking places set aside for the recharging of electric motorcycles and electric vehicles on roads for which the City of Westminster is the traffic authority, hereby:-

- authorises the erection at appropriate sites on the said roads of a traffic sign
 (hereinafter referred to as "the authorised sign A") conforming as to size, colour and
 character with that shown on the attached drawing numbered GT50/024/0057-1,
 save that references to days of the week and times of the day may be varied and
 references to the maximum stay period may be varied or omitted; and
- authorises the erection at appropriate sites on the said roads of a traffic sign
 (hereinafter referred to as "the authorised sign B") conforming as to size, colour and
 character with that shown on the attached drawing numbered GT50/024/0057-2,
 save that references to days of the week and times of the day may be varied and
 references to the maximum stay period may be varied or omitted; and
- 3. authorises the placing on the carriageway in the vicinity of the authorised sign A of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking A") conforming as to size, colour and character with that to diagram 1028.4 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of S.I. 2002/3113, "the 2002 Regulations") as amended by the Traffic Signs (Amendment) (No.2) Regulations 2011 (S.I. No. 3041, "the 2011 Regulations"), save that the legend may be varied to "ELECTRIC M/CS" or "ELECTRIC M/CS ONLY"; and



- 4. authorises the placing on the carriageway in the vicinity of the authorised sign B of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking B") conforming as to size, colour and character with that to diagram 1032 in Schedule 6 to the 2002 Regulations as amended by the 2011 Regulations, save that the legend "ELEC VEH ONLY" or "ELECTRIC VEHICLES ONLY" may be added in the manner shown in diagram 1028.4 in Schedule 6 to those Regulations; and
- directs that the authorised sign A shall only be used in conjunction with the authorised marking A and the authorised sign B shall only be used in conjunction with the authorised marking B; and
- directs that it is a condition of this authorisation that the authorised signs A and B
 and the authorised markings A and B may be placed only to indicate the effect of a
 corresponding Traffic Order; and
- 7. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B and the authorised markings A and B, at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A and B and the authorised markings A and B, and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.



The provisions of Regulations 12, 18 and 19 of the 2002 Regulations, as amended by the 2011 regulations, shall apply to the authorised sign A and B in the same manner as they apply to the sign to diagram 660.9 in Schedule 2 to the 2002 Regulations as amended by the 2011 Regulations.

The provisions of Regulations 12 and 31 of the 2002 Regulations, as amended by the 2011 Regulations, shall apply to the authorised marking A in the same manner as they apply to the sign to diagram 1028.4 in Schedule 6 to the 2002 Regulations as amended by the 2011 Regulations.

The provisions of Regulations 12 and 31 of the 2002 Regulations, as amended by the 2011 Regulations, shall apply to the authorised marking B in the same manner as they apply to the sign to diagram 1032 in Schedule 6 to the 2002 Regulations as amended by the 2011 Regulations.
