

ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of a time-limited banned right turn in King Street, Twickenham, in the London Borough of Richmond upon Thames, hereby:-

- authorises the erection at or within 5 metres of the site indicated on the attached plan numbered GT50/093/0010-1 of a traffic sign consisting of a plate (hereinafter referred to as "the authorised plate") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/093/0010-2; and
- directs that the authorised plate shall only be used with the sign to diagram 612 in Schedule 2 to the Traffic Signs Regulations 2002 (Part I of S.I. 2002/3113, "the 2002 Regulations"); and
- directs that the provisions of Direction 21(1) of the Traffic Signs Directions 2002
 (Part II of S.I. 2002/3113) shall not apply to the sign to diagram 613 in Schedule 2
 of the 2002 Regulations when used with the authorised plate; and
- 4. directs that it is a condition of this authorisation that the authorised plate may be placed only to indicate the effect of a corresponding Traffic Order; and
- 5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised plate at or near the said site shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised plate and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.



The provisions of Regulations 12 and 20 of the 2002 Regulations shall apply to the authorised plate in the same manner as they apply to the plate shown in diagram 620 when used in conjunction with the sign to diagram 612 in Schedule 2 to those Regulations.


