

ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of the conditions of a bus lane on Spinning Jenny Way, Leigh, Greater Manchester, hereby:-

- authorises the erection at or within 5 metres of the sites indicated schematically on the attached plan numbered GT50/184/0008-1 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown on the attached drawing numbered NP 959.5, save that the cycle symbol and the legend "taxi" may be removed; and
- authorises the erection at or within 5 metres of the site indicated schematically on the said plan of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown on the attached drawing numbered NP 958.10; and
- directs that, notwithstanding the provisions of Direction 18(3) of the Traffic Signs
 General Directions 2002, the authorised sign A may be used with the road markings
 to diagrams 1048 and 1049 in Schedule 6 to the 2002 Regulations; and
- directs that the authorised sign B may be used with the road marking to Diagram 1010 in Schedule 6 to those Regulations.
- directs that it is a condition of this authorisation that the authorised signs A and B may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and



6. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A and B and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign to diagram 959 in Schedule 5 to the 2002 Regulations.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign to diagram 958 in Schedule 5 to those Regulations.






