

ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of parking places wholly or partially on the footway, on roads for which the London Borough of Redbridge is the traffic authority, hereby:-

- authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that referenced "FW1v2" on the attached set of drawings numbered GT50/092/0008-1; and
- authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that referenced "FW2" on the said set of drawings; and
- authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign C") conforming as to size, colour and character with that referenced "FW3" on the said set of drawings; and
- authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign D") conforming as to size, colour and character with that referenced "FW4" on the said set of drawings; and
- authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign E") conforming as to size, colour and character with that referenced "FW5a" on the said set of drawings; and



- 6. authorises the placing at the said sites of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking") conforming as to size, colour and character with that to diagram 1028.3 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of S.I. 2002/3113, "the 2002 Regulations"), as amended by the Traffic Signs (Amendment) (No. 2) Regulations 2011 (S.I. 2011/3041, "the Amendment Regulations"), save that the marking may be placed wholly or partially on the footway; and
- directs that it is a condition of this authorisation that the authorised signs A-E
 may only be used to indicate the effect of a corresponding Traffic Order; and
- directs that references to the time of the day or day of the week in authorised signs A, B, C, and E may be varied; and
- directs that the code identifier patch in authorised signs A, D and E may be varied as appropriate; and
- 10. directs that in authorised sign A references to the telephone number and location number, and the maximum stay and time within which return is prohibited, may be varied and the arrow may be omitted or varied to show it pointing horizontally to the right; and
- 11. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A-E and the placing of the authorised marking, at or near the said sites, shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A-E and the authorised marking and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.



The provisions of Regulations 12, 18 and 19 of the 2002 Regulations, as amended by the Amendment Regulations, shall apply to the authorised sign A in the same manner as they apply to the sign shown in diagram 660.7 in Schedule 2 to those Regulations.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations, as amended by the Amendment Regulations, shall apply to the authorised signs B and C in the same manner as they apply to the sign shown in diagram 639.1B in Schedule 2 to those Regulations as amended by the Amendment Regulations.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations, as amended by the Amendment Regulations, shall apply to the authorised signs D and E in the same manner as they apply to the sign shown in diagram 663.3 in Schedule 2 to those Regulations.
