

## ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Section 65 of the Road Traffic Regulation Act 1984, and all other powers enabling him in that behalf, for the purpose of informing road users of parking places and restrictions within pedestrian zones on roads for which the London Borough of Hackney is the traffic authority, hereby:-

- authorises the erection on the said roads of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown in the attached drawing numbered GT50/080/0021-1; save that
  - a) the references to the time limit, the time of day or the day of the week may be varied or omitted; and
  - b) references to the month of the year may be added; and
  - c) references to bank or public holidays may be included; and
  - d) the legend "Permit holders" may be omitted, in which case the parking permit identification code letter patch and the word "or" shall also be omitted; and
  - e) the parking permit identification code letter patch, the telephone number, or the location code may be varied; and
  - f) the legend "or text" may be added, in which case a text number shall be added; and
  - g) the legend "Pay at machine" may be replaced by the legend "Pay at machine opposite" (on two lines), in which case the arrow shall be omitted; and
  - h) the legend "Pay at machine" may be replaced by the legend "Pay here at machine" (on two lines), in which case the arrow shall be omitted; and



- i) an arrow pointing horizontally to the left or to the right may be added below the reference to the time of day; and
- j) the direction in which an arrow points may be varied with the arrow pointing horizontally to the left or to the right; and
- 2. directs that it is a condition of this authorisation that the authorised sign may be placed only to indicate the effect of a corresponding Traffic Order; and
- 3. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign at the said site shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the Traffic Signs Regulations 2002 (Part I of SI 2002 No.3113) shall apply to the authorised sign in the same manner as they apply to the sign to diagram 639.1B in Schedule 2 to those Regulations.

Sign based on 639.1b to be used in roads where a pedestrian zone is in operation on some days and waiting restrictions apply on other days.

This example features 2 panels based on the following signs:

Panel A Sign G from G50/080/0007 (the pay by phone sign that has no diagram number)

Panel B Sign 637.2

## **Permitted Variants**

The following may be added, varied or omitted as appropriate:

Telephone number, location number, max stay, no return time, zone indicator logo, borough name and logo, arrow indicating nearest machine, day(s) and times.

The wording "Pay at machine Display ticket" may be changed to "Pay at machine across road" if the arrow between these two lines is omitted.

Panel A may be varied to those signs listed in TSRGD 2002, Schedule 16, Item 39 or 660.8 or 660.9.

Panel B may be varied so as to match the no waiting panel displayed in diagram 639 or 637.2a. In both instances, the x height of the text may be varied to 15mm and the height of the roundel to 75mm.

Panel B may be positioned above panel A where the restrictions described in panel B begin before those in panel A (the first day of the week being Monday and the earliest start time being Midnight).

Where loading restrictions apply, a 3rd panel may be added below panel B, featuring all wording, symbols and variants permitted under 638.1 with the exception that the x height of this panel shall be 15mm.

The 'P' symbol may be used to the left of the days/times
