

## ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing motorists of restrictions, requirements or prohibitions and information at appropriate sites, for which Norfolk County Council is the traffic authority, hereby:-

- 1. authorises the erection at appropriate sites of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/107/0021-1 save that references to times of day, days of the week or dates may be added; and
- authorises the erection at appropriate sites of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with the attached drawing numbered GT50/107/0021-2 save that:
  - (a) information regarding the time of day, date or dates, (with the year omitted) and location of the suspended parking place or places shall be shown on the authorised sign B; and
  - (b) information regarding the type of parking place, the reason for the parking suspension, or an identifying reference may be shown on the authorised sign B; and
- directs that it is a condition of this authorisation that the authorised sign A may only be placed to indicate the effect of a corresponding Traffic Regulation Order; and



- 4. directs that, notwithstanding the provisions of Direction 25 of the Traffic Signs General Directions 2002 (Part II of S.I. 2002/3113), the authorised sign A may be used with either no road markings, or with any kerbside road marking in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of S.I. 2002/3113, "the 2002 Regulations"), as amended by the Traffic Signs (Amendment) (No. 2) Regulations 2011 (S.I. 2011/3041); and
- directs that the authorised sign B may not be erected at the same location for longer than six months; and
- 6. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the placing of the authorised signs A and B at or near the said sites, shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A and B and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect; and

The provisions of Regulation 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign in diagram 650.1 in Schedule 2 to those Regulations.

The provisions of Regulation 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign in diagram 636 in Schedule 2 to those Regulations.


