

ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of provisions for e-taxis on roads in the City of Westminster, hereby:-

- authorises the erection at appropriate sites on roads for which the City of Westminster Council is the traffic authority of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown in the attached drawing numbered GT50/024/0074-1; and
- 2. authorises the erection at the said sites of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown in the attached drawing numbered GT50/024/0074-2; and
- 3. authorises the erection at the said sites of a traffic sign (hereinafter referred to as "the authorised sign C") conforming as to size, colour and character with that shown in the attached drawing numbered GT50/024/0074-3 save that references to the number of e-taxis may be varied or omitted; and
- 4. authorises the placing at the said sites of a road marking (hereinafter referred to as "the authorised marking") conforming as to size, colour and character with that shown in Diagram 1028.2 of Schedule 7, Part 4, Item 5 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, "the 2016 Regulations") save that the legend "TAXIS" shall be replaced with the legend "E-TAXIS"; and



- directs that references on the authorised signs A and B to time periods,
 times of the day, days of the week or times within which return is prohibited
 may be varied or omitted; and
- 6. directs that the authorised signs A and B and the authorised marking shall only be placed to indicate the effect of a corresponding Traffic Order; and
- 7. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A-C and the placing of the authorised marking at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A-C and the authorised marking and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 7 and 8 of the 2016 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign shown in Schedule 4, Part 3, Item 2 of those Regulations.

The provisions of Regulations 7 and 8 of the 2016 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign shown in Schedule 4, Part 5, Item 7 of those Regulations.

The provisions of Regulations 7 and 8 of the 2016 Regulations shall apply to the authorised sign C in the same manner as they apply to the sign shown in Schedule 11, Part 2, Item 48 of those Regulations.





The provisions of Regulations 7, 9 and 10 of the 2016 Regulations shall apply to the authorised marking in the same manner as they apply to the road marking shown in diagram 1028.2 in Schedule 7, Part 4, Item 5 of those Regulations.


