

## Road Traffic Regulation Act 1984 Sections 64 and 65

## Authorisation of traffic signs and special directions

Secretary of State for Transport's traffic authorisation of signs/markings for the purpose of informing road users of access restrictions at French Street in Southampton for which Southampton City Council is the traffic authority - accessible transcript.

## ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of access restrictions at French Street in Southampton, hereby:-

- authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/150/0052-1 for which Southampton City Council is the traffic authority of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/150/0052-2; save that (i) references to times of day and days of the week may be varied or omitted; and (ii) the name of the traffic authority may be added in a panel above the upper panel; and
- directs that it is a condition of this authorisation that the authorised sign may only be placed to indicate the effect of a corresponding Traffic Regulation Order; and
- 3. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 5, 6, 7, 8 and 11 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, "the 2016 Regulations") shall apply to the authorised sign in the same manner as they apply to the sign to diagram 618.3C shown in Schedule 8, Part 2, Item 2 of those Regulations.




