Secretary of State for Transport's traffic authorisation of signs/markings for the purpose of informing road users of conditions attached to parking places for electric vehicles on roads for which Westminster City Council is the traffic authority.

ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of conditions attached to parking places for electric vehicles on roads for which Westminster City Council is the traffic authority, hereby:-

- 1. authorises the erection at appropriate sites of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown in the attached drawing numbered GT50/024/0076-1 save that (a) the x-height may be varied to not less than 15 mm and not more than 40 mm; (b) the legend "Resident permit" may be replaced with the legend "Permit"; (c) the permit identifier may be varied or omitted as appropriate; (d) the time period may be varied to a permitted expression of time periods, days and dates; (e) the legend indicating the parking restrictions may be varied, omitted or amended to a permitted expression for parking restriction signs; (f) a parking place identifier or a zone identifier may be included; (g) an arrow pointing to the left or to the right where indicating the beginning of, or a change in, a restriction or prohibition may be included; (h) the name and/or logo of the traffic authority may be omitted; and (i) the legend "No return within same day" may be omitted; and
- directs that the road marking shown in Diagram 1028.4 of Schedule 7, Part 4, Item 6 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, "the 2016 Regulations") may be used with the authorised sign; and
- directs that the authorised sign shall only be placed to indicate the effect of a corresponding Traffic Regulation Order; and



4. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 5, 6, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign in the same manner as they apply to the sign shown in Schedule 4, Part 5, Item 7 of those Regulations.

The provisions of Schedule 4, Parts 2, 4 and 6 of the 2016 Regulations shall apply to the authorised sign in the same manner as they apply to the sign shown in Schedule 4, Part 5, Item 7 of those Regulations.

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of conditions attached to parking places for electric vehicles on roads for which Westminster City Council is the traffic authority, hereby:-

- authorises the erection at appropriate sites of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown in the attached drawing numbered GT50/024/0076-1 save that

 (a) the x-height may be varied to not less than 15 mm and not more than 40 mm;
 (b) the legend "Resident permit" may be replaced with the legend "Permit";
 (c) the permit identifier may be varied or omitted as appropriate;
 (d) the time period may be varied to a permitted expression of time periods, days and dates;
 (e) the legend indicating the parking restrictions may be varied, omitted or amended to a permitted expression for parking restriction signs;
 (f) a parking place identifier or a zone identifier may be included;
 (g) an arrow pointing to the left or to the right where indicating the beginning of, or a change in, a restriction or prohibition may be included;
 (h) the name and/or logo of the traffic authority may be omitted; and (i) the legend "No return within same day" may be omitted; and
- directs that the road marking shown in Diagram 1028.4 of Schedule 7, Part 4, Item 6 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, "the 2016 Regulations") may be used with the authorised sign; and
- directs that the authorised sign shall only be placed to indicate the effect of a corresponding Traffic Regulation Order; and



4. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 5, 6, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign in the same manner as they apply to the sign shown in Schedule 4, Part 5, Item 7 of those Regulations.

The provisions of Schedule 4, Parts 2, 4 and 6 of the 2016 Regulations shall apply to the authorised sign in the same manner as they apply to the sign shown in Schedule 4, Part 5, Item 7 of those Regulations.
