### Authorisation of traffic signs and special directions

#### Accessible transcript

Secretary of State for Transport's traffic authorisation of traffic signs for the purpose of informing road users of the conditions of a bus lane in Sheffield Road, Rotherham for which Rotherham Metropolitan Borough Council is the traffic authority.

**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65  
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of the conditions of a bus lane in Sheffield Road, Rotherham for which Rotherham Metropolitan Borough Council is the traffic authority, hereby:-

1. authorises the erection at or within 5 metres of the sites marked schematically on the attached plan numbered GT50/147/0011-1 of a traffic sign (hereinafter referred to as “the authorised sign A”) conforming as to size, colour and character with that shown at “Sign A” on the attached drawing numbered GT50/147/0011-2 save that a panel indicating a time period as shown in the sign in Schedule 11, Part 2, Item 37 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, “the 2016 Regulations”) may be added at the bottom of the authorised sign A; and
2. authorises the erection at or within 5 metres of the sites marked schematically on the attached plan numbered GT50/147/0011-1 of a traffic sign (hereinafter referred to as “the authorised sign B”) conforming as to size, colour and character with that shown at “Sign B” on the attached drawing numbered GT50/147/0011-2 save that a panel indicating a time period as shown in the sign in Schedule 9, Part 4, Item 10 of the 2016 Regulations may be added at the bottom of the authorised sign B; and
3. directs that the provisions of Schedule 11, Parts 1 to 7 of the 2016 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign shown in Schedule 11, Part 2, Item 37 of those Regulations; and
4. directs that the provisions of Schedule 9, Parts 1 to 9 of the 2016 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign shown in Schedule 9, Part 4, Item 10 of those Regulations; and



5. directs that it is a condition of this authorisation that the authorised sign B may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and
6. directs without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B at the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A and B and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 5, 6, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign shown in diagram 958 in Schedule 11, Part 2, Item 37 of those Regulations.

The provisions of Regulations 5, 6, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign shown in diagram 959B in Schedule 9, Part 4, Item 10 of those Regulations.

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of the conditions of a bus lane in Sheffield Road, Rotherham for which Rotherham Metropolitan Borough Council is the traffic authority, hereby:-

1. authorises the erection at or within 5 metres of the sites marked schematically on the attached plan numbered GT50/147/0011-1 of a traffic sign (hereinafter referred to as “the authorised sign A”) conforming as to size, colour and character with that shown at “Sign A” on the attached drawing numbered GT50/147/0011-2 save that a panel indicating a time period as shown in the sign in Schedule 11, Part 2, Item 37 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, “the 2016 Regulations”) may be added at the bottom of the authorised sign A; and
2. authorises the erection at or within 5 metres of the sites marked schematically on the attached plan numbered GT50/147/0011-1 of a traffic sign (hereinafter referred to as “the authorised sign B”) conforming as to size, colour and character with that shown at “Sign B” on the attached drawing numbered GT50/147/0011-2 save that a panel indicating a time period as shown in the sign in Schedule 9, Part 4, Item 10 of the 2016 Regulations may be added at the bottom of the authorised sign B; and
3. directs that the provisions of Schedule 11, Parts 1 to 7 of the 2016 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign shown in Schedule 11, Part 2, Item 37 of those Regulations; and
4. directs that the provisions of Schedule 9, Parts 1 to 9 of the 2016 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign shown in Schedule 9, Part 4, Item 10 of those Regulations; and



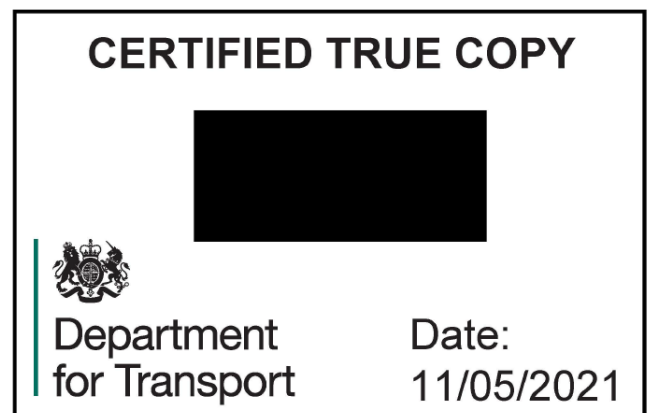
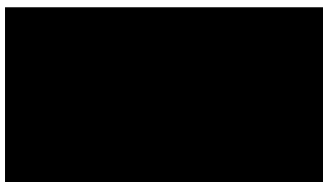
5. directs that it is a condition of this authorisation that the authorised sign B may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and
6. directs without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B at the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A and B and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 5, 6, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign shown in diagram 958 in Schedule 11, Part 2, Item 37 of those Regulations.

The provisions of Regulations 5, 6, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign shown in diagram 959B in Schedule 9, Part 4, Item 10 of those Regulations.

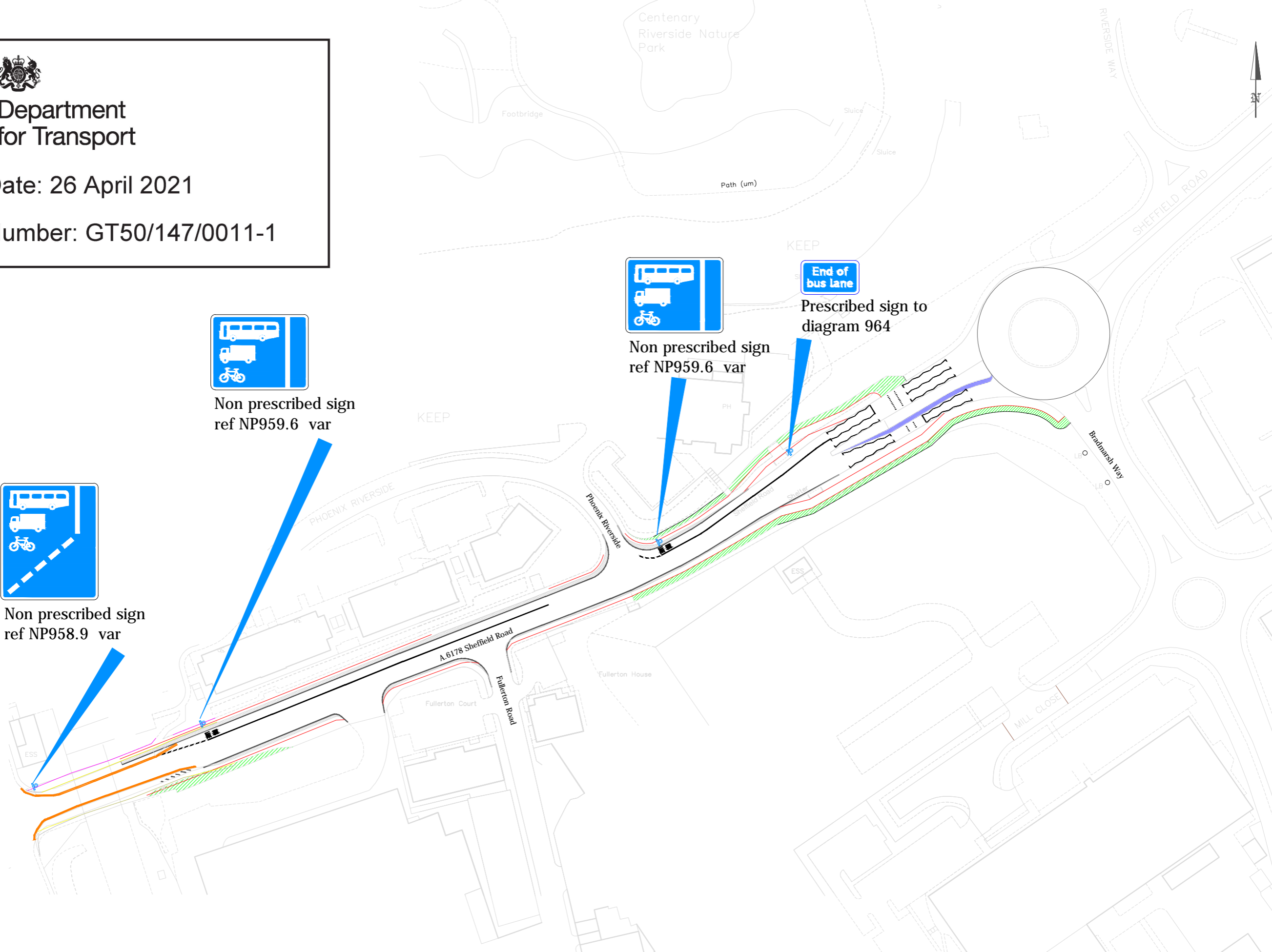

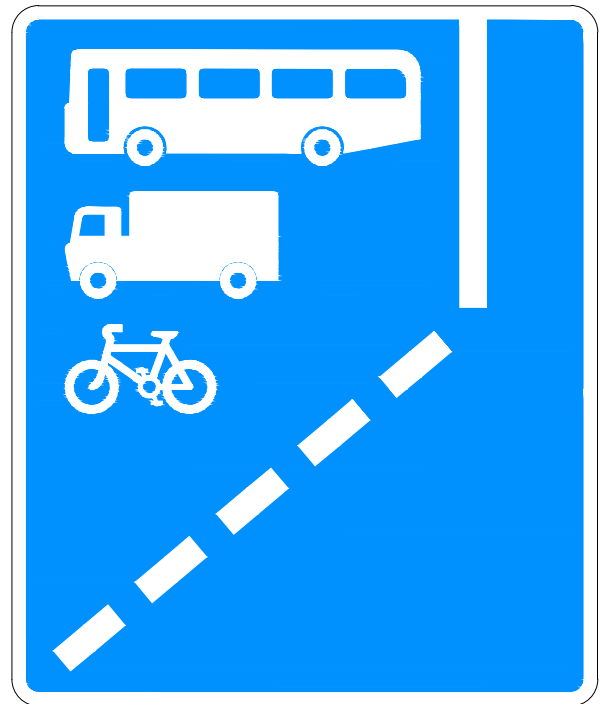
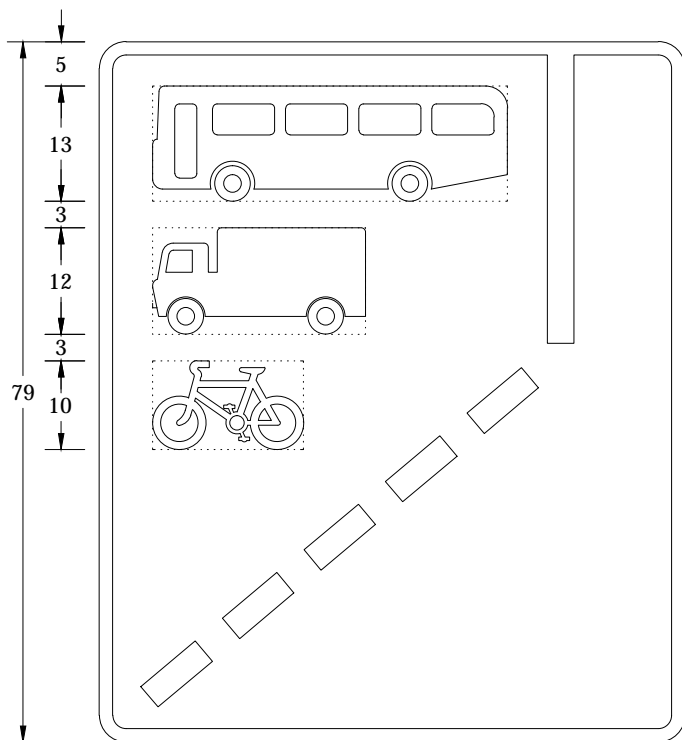


End of

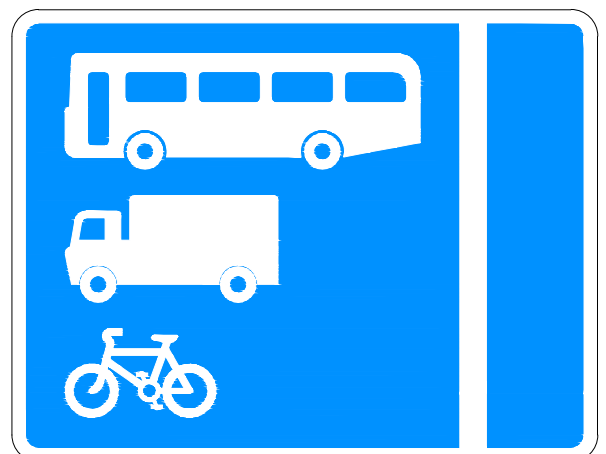
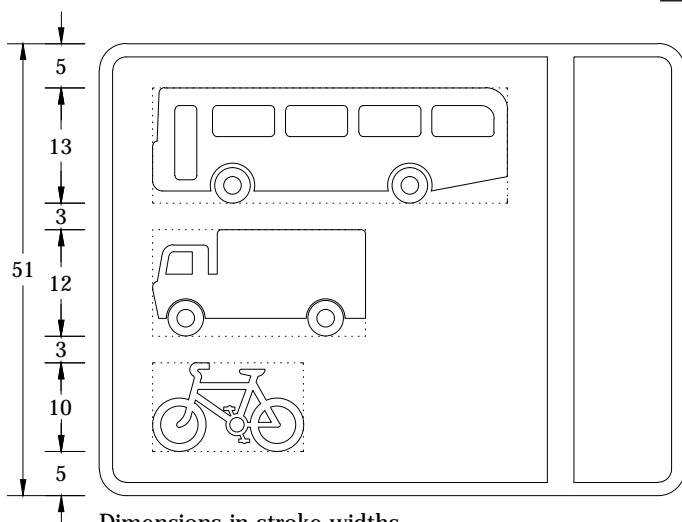
