Authorisation of traffic signs and special directions

Accessible transcript

Secretary of State for Transport's traffic authorisation of traffic signs for the purpose of informing road users of e-scooter and cycle hire parking places on roads for which Coventry City Council is the traffic authority.

The following pages contain a copy of the text from the Secretary of State for Transport's traffic authorisation regarding the above traffic signs.

AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of e-scooter and cycle hire parking places on roads for which Coventry City Council is the traffic authority, hereby:-

1. authorises the placing on the said roads of a traffic sign consisting of a road marking (hereinafter referred to as “the authorised marking”) conforming as to size, colour and character with that shown on the attached drawing numbered NP 1028.7; and
2. directs that it is a condition of this authorisation that the authorised marking shall be placed only to indicate the effect of a corresponding Traffic Regulation Order; and
3. directs that this authorisation shall remain in force until 31 March 2023, and after that date shall, without prejudice to giving of any further authorisation, cease to have effect. This authorisation may also cease to have effect on a date as may be appointed by one month’s notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised marking and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Schedule 7, Parts 1 to 7 of the Traffic Signs Regulations 2016 (Part I of SI 2016/362, “the 2016 Regulations”) shall apply to the authorised marking in the same manner as they apply to the road marking shown in diagram 1028.4 in Schedule 7, Part 4, Item 6 of those Regulations.



The provisions of Regulations 5, 7, 9 and 10 of the 2016 Regulations shall apply to the authorised marking in the same manner as they apply to the road marking shown in diagram 1028.4 in Schedule 7, Part 4, Item 6 of those Regulations.
