Secretary of State for Transport's traffic authorisation of traffic signs for the purpose of giving directions to road users on the A1 all purpose trunk road between junctions 74 and 77, and where National Highways is the traffic authority.

**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and all other powers enabling him in that behalf for the purpose of giving directions to road users on the A1 all purpose trunk road between junctions 74 and 77, and where National Highways is the traffic authority, hereby:-

1. authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/198/0094-1 of a traffic sign (hereinafter referred to as “the authorised sign A”) conforming as to size, colour and character with that shown on the attached drawing numbered GT50/198/0094-2; and
2. authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/198/0094-3 of a traffic sign (hereinafter referred to as “the authorised sign B”) conforming as to size, colour and character with that shown on the attached drawing numbered GT50/198/0094-4; and
3. authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/198/0094-5 of a traffic sign (hereinafter referred to as “the authorised sign C”) conforming as to size, colour and character with that shown on the attached drawing numbered GT50/198/0094-6; and
4. authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/198/0094-7 of a traffic sign (hereinafter referred to as “the authorised sign D”) conforming as to size, colour and character with that shown on the attached drawing numbered GT50/198/0094-8; and



5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A, B, C and D at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A, B, C and D and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 5, 7, 8 and 11 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, "the 2016 Regulations") shall apply to the authorised signs A, B, C and D in the same manner as they apply to the signs shown in Schedule 12, Part 2, Item 2 to those Regulations.

The provisions of Schedule 12, Parts 1 to 29 of the 2016 Regulations shall apply to the authorised signs A, B, C and D in the same manner as they apply to the signs shown in Schedule 12, Part 2, Item 2 of those Regulations.

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and all other powers enabling him in that behalf for the purpose of giving directions to road users on the A1 all purpose trunk road between junctions 74 and 77, and where National Highways is the traffic authority, hereby:-

1. authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/198/0094-1 of a traffic sign (hereinafter referred to as “the authorised sign A”) conforming as to size, colour and character with that shown on the attached drawing numbered GT50/198/0094-2; and
2. authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/198/0094-3 of a traffic sign (hereinafter referred to as “the authorised sign B”) conforming as to size, colour and character with that shown on the attached drawing numbered GT50/198/0094-4; and
3. authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/198/0094-5 of a traffic sign (hereinafter referred to as “the authorised sign C”) conforming as to size, colour and character with that shown on the attached drawing numbered GT50/198/0094-6; and
4. authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/198/0094-7 of a traffic sign (hereinafter referred to as “the authorised sign D”) conforming as to size, colour and character with that shown on the attached drawing numbered GT50/198/0094-8; and



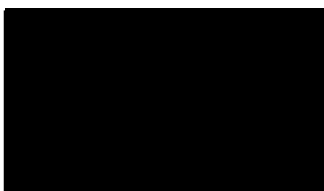
5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A, B, C and D at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A, B, C and D and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 5, 7, 8 and 11 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, "the 2016 Regulations") shall apply to the authorised signs A, B, C and D in the same manner as they apply to the signs shown in Schedule 12, Part 2, Item 2 to those Regulations.

The provisions of Schedule 12, Parts 1 to 29 of the 2016 Regulations shall apply to the authorised signs A, B, C and D in the same manner as they apply to the signs shown in Schedule 12, Part 2, Item 2 of those Regulations.
