Authorisation of traffic signs and special directions

Accessible transcript

Secretary of State for Transport's traffic authorisation of traffic signs for the purpose of informing road users of an exception for vehicles less than 7.5t to a left turn prohibition at the junction of Warwick Way and Denbigh Street in London and for which Westminster City Council is the traffic authority.

The following pages contain a copy of the text from the Secretary of State for Transport's traffic authorisation regarding the above traffic signs.

ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of an exception for vehicles less than 7.5t to a left turn prohibition at the junction of Warwick Way and Denbigh Street in London and for which Westminster City Council is the traffic authority, hereby:-

- authorises the erection at or within 5 metres of the site shown schematically
 on the attached plan numbered GT50/024/0085-1 of a traffic sign consisting of
 a plate (hereinafter referred to as "the authorised plate") conforming as to size,
 colour and character with that referenced AUTH PLATE on the attached
 drawing numbered GT50/024/0085-2; and
- directs that the authorised plate shall only be used with the sign to diagram 613 in Schedule 3, Part 2, Item 8 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, "the 2016 Regulations") and the sign shown in Schedule 12, Part 20, Item 19 of those Regulations; and
- 3. directs that the provisions of Schedule 3, Parts 1 to 5 of the 2016 Regulations shall apply to the authorised plate in the same manner as they apply to the sign described in Schedule 3, Part 3, Paragraph 3 of those Regulations; and
- 4. directs that the provisions of Schedule 12, Parts 1 to 29 of the 2016 Regulations shall apply to the authorised plate when used on a Schedule 12 directional sign, in the same manner as they apply to the sign shown in Schedule 12, Part 20, Item 45 of those Regulations; and
- 5. authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/024/0085-1 of a traffic sign consisting of a sign (hereinafter referred to as "the authorised sign") conforming as to size,



colour and character with that referenced AUTH SIGN on the attached drawing numbered GT50/024/0085-2; and

- 6. directs that the authorised sign shall only be used with the traffic signal to diagram 3000 in Schedule 14, Part 2, Item 1 of the 2016 Regulations; and
- 7. directs that the provisions of Schedule 14, Parts 1 to 6 of the 2016 Regulations shall apply to the authorised sign in the same manner as they apply to the sign described in Schedule 14, Part 2, Item 45 of those Regulations; and
- directs that it is a condition of this authorisation that the authorised plate and the authorised sign may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and
- 9. authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/024/0085-1 of a sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that referenced AUTH SIGN on the attached drawing numbered GT50/024/0085-2traffic signal conforming as to size, colour and character with that to in combination with a; and
- 10. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised plate and the authorised sign at or near the said site shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised plate and the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.



The provisions of Regulations 5, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised plate in the same manner as they apply to the plate described in Schedule 3, Part 3, Paragraph 3 and to the sign shown in Schedule 12, Part 20, Item 45 of those Regulations.

The provisions of Regulations 5, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign in the same manner as they apply to the sign described in Schedule 14, Part 2, Item 45 of those Regulations.

 a plate (hereinafter referred to as "the authorised plate") conforming as to size,
 colour and character with that referenced AUTH PLATE on the attached
 drawing numbered GT50/024/0085-2; and
- directs that the authorised plate shall only be used with the sign to diagram 613 in Schedule 3, Part 2, Item 8 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, "the 2016 Regulations") and the sign shown in Schedule 12, Part 20, Item 19 of those Regulations; and
- 3. directs that the provisions of Schedule 3, Parts 1 to 5 of the 2016 Regulations shall apply to the authorised plate in the same manner as they apply to the sign described in Schedule 3, Part 3, Paragraph 3 of those Regulations; and
- 4. directs that the provisions of Schedule 12, Parts 1 to 29 of the 2016 Regulations shall apply to the authorised plate when used on a Schedule 12 directional sign, in the same manner as they apply to the sign shown in Schedule 12, Part 20, Item 45 of those Regulations; and
- 5. authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/024/0085-1 of a traffic sign consisting of a sign (hereinafter referred to as "the authorised sign") conforming as to size,



colour and character with that referenced AUTH SIGN on the attached drawing numbered GT50/024/0085-2; and

- 6. directs that the authorised sign shall only be used with the traffic signal to diagram 3000 in Schedule 14, Part 2, Item 1 of the 2016 Regulations; and
- 7. directs that the provisions of Schedule 14, Parts 1 to 6 of the 2016 Regulations shall apply to the authorised sign in the same manner as they apply to the sign described in Schedule 14, Part 2, Item 45 of those Regulations; and
- directs that it is a condition of this authorisation that the authorised plate and the authorised sign may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and
- 9. authorises the erection at or within 5 metres of the site shown schematically on the attached plan numbered GT50/024/0085-1 of a sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that referenced AUTH SIGN on the attached drawing numbered GT50/024/0085-2traffic signal conforming as to size, colour and character with that to in combination with a; and
- 10. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised plate and the authorised sign at or near the said site shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised plate and the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.







Proposed non-prescribed sign with supplementary text within red box to be installed on new traffic signal. The sign face and supplementry text is proposed to restrict larger vehicles turning left westward from Denbigh Street to Warwick Way. It does not restrict larger vehicles travelling east to west along Warwick Way, travelling northwards from Denbigh Street to Wilton Road or turning right westward from Wilton Road to Warwick Way.


The proposed road geometry does not allow larger vehicles to left turn from Denbigh Street to Warwick Way. The manoeuvre would not be safe and will lead to an encroachment onto the contraflow cycle lane.

The proposed road geometry does not allow larger vehicles to left turn from Denbigh Street to Warwick Way. The manoeuvre would not be safe and will lead to an encroachment onto the contraflow cycle lane.

The sign is proposed to restrict larger vehicles turning left westward from Denbigh Street to Warwick Way. It does not restrict larger vehicles travelling east to west along Warwick Way, travelling northwards from Denbigh Street to Wilton Road or turning right westward from Wilton Road to Warwick Way. All vehicle types except cycles are prohibited from turning right from Denbigh Street to Warwick Way.
