

## Road Traffic Regulation Act 1984 Sections 64 and 65

### Authorisation of traffic signs and special directions

#### Accessible transcript

Secretary of State for Transport's traffic authorisation of traffic signs for the purpose of informing drivers of the location of a Clean Air Zone area.

The following pages contain a copy of the text from the Secretary of State for Transport's traffic authorisation regarding the above traffic signs.

#### ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport in exercise of powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, hereby gives the authorisation contained in paragraphs 2 and 3 of this Instrument and the directions contained in paragraph 4 of this Instrument.

1. In this Instrument –

"Authorised sign" means a traffic sign whose placing on roads is authorised by paragraph 2;

"the Clean Air Zone" means the area in respect of which charges are imposed for the keeping or use of motor vehicles not meeting certain emission standards pursuant to a Scheme;

"Scheme" means a scheme for imposing charges made in respect of keeping or use of certain motor vehicles not meeting certain emission standards, made by City of Bradford Metropolitan District Council pursuant to Part III and Schedule 12 of the Transport Act 2000, Parts 2 and 6 of The Road User Charging Schemes (Penalty Charges, Adjudication and Enforcement) (England) Regulations 2013 and of all other powers enabling it in that behalf;

"the 2016 Regulations" means the Traffic Signs Regulations and General Directions 2016 (Part 1 of S.I. 2016/362).

- 2. The Secretary of State hereby:-
- (1) authorises the erection at or within 5 metres of the site shown schematically on the attached plan number GT50/198/0106-1 for which National Highways is the traffic authority, of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown on the attached

drawing numbered GT50/198/0106-2 save that the alphabet indicating the class on the Clean Air Zone symbol may be varied to one shown on the attached drawing referenced S 68; and

(2) directs that the Clean Air Zone symbol shown in the said set of drawings (hereinafter referred to as "the authorised symbol S 68") conforming as to size, colour and character with that referenced S 68 in the said set of drawings may be placed on any appropriate sign in Schedule 12 of the 2016 Regulations in the same manner as the symbols mentioned in Schedule 12, Parts 11 and 20 to those Regulations; and

3.

- (1) The provisions of Regulations 5, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign as they do to the sign shown in Item 1 (Type A) of the sign table in Schedule 12, Part 2 to those Regulations.
- (2) The provisions of Regulations 5, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised symbol S 68 as they do to the symbol shown in Item 19 of the sign table in Schedule 12, Part 11 to those Regulations.
  - 4. The Secretary of State hereby directs that -
- (1) The authorised sign and the authorised symbol S 68 when incorporated on Schedule 12 signs in the 2016 Regulations, may be placed only as appropriate to indicate the provisions of a Scheme.
- (2) Without prejudice to any statutory provision to the like effect, it is a condition of this authorisation that the placing of the authorised sign and signs incorporating the authorised symbol S 68 on or near the said roads shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of



the authorised sign and/or other applicable signs and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

1. In this Instrument –

"Authorised sign" means a traffic sign whose placing on roads is authorised by paragraph 2;

"the Clean Air Zone" means the area in respect of which charges are imposed for the keeping or use of motor vehicles not meeting certain emission standards pursuant to a Scheme;

"Scheme" means a scheme for imposing charges made in respect of keeping or use of certain motor vehicles not meeting certain emission standards, made by City of Bradford Metropolitan District Council pursuant to Part III and Schedule 12 of the Transport Act 2000, Parts 2 and 6 of The Road User Charging Schemes (Penalty Charges, Adjudication and Enforcement) (England) Regulations 2013 and of all other powers enabling it in that behalf;

"the 2016 Regulations" means the Traffic Signs Regulations and General Directions 2016 (Part 1 of S.I. 2016/362).

- 2. The Secretary of State hereby:-
- (1) authorises the erection at or within 5 metres of the site shown schematically on the attached plan number GT50/198/0106-1 for which National Highways is the traffic authority, of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown on the attached

drawing numbered GT50/198/0106-2 save that the alphabet indicating the class on the Clean Air Zone symbol may be varied to one shown on the attached drawing referenced S 68; and

(2) directs that the Clean Air Zone symbol shown in the said set of drawings (hereinafter referred to as "the authorised symbol S 68") conforming as to size, colour and character with that referenced S 68 in the said set of drawings may be placed on any appropriate sign in Schedule 12 of the 2016 Regulations in the same manner as the symbols mentioned in Schedule 12, Parts 11 and 20 to those Regulations; and

3.

- (1) The provisions of Regulations 5, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign as they do to the sign shown in Item 1 (Type A) of the sign table in Schedule 12, Part 2 to those Regulations.
- (2) The provisions of Regulations 5, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised symbol S 68 as they do to the symbol shown in Item 19 of the sign table in Schedule 12, Part 11 to those Regulations.
  - 4. The Secretary of State hereby directs that -
- (1) The authorised sign and the authorised symbol S 68 when incorporated on Schedule 12 signs in the 2016 Regulations, may be placed only as appropriate to indicate the provisions of a Scheme.
- (2) Without prejudice to any statutory provision to the like effect, it is a condition of this authorisation that the placing of the authorised sign and signs incorporating the authorised symbol S 68 on or near the said roads shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of

the authorised sign and/or other applicable signs and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.








M606 JUNCTION 3 NORTHBOUND EXIT SLIP.
