## Road Traffic Regulation Act 1984 Sections 64 and 65

### Authorisation of traffic signs and special directions

#### Accessible transcript

Secretary of State for Transport's traffic authorisation of traffic signs for the purpose of informing road users of access restrictions on roads for which Oxfordshire County Council is the traffic authority.

The following pages contain a copy of the text from the Secretary of State for Transport's traffic authorisation regarding the above traffic signs.

**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65**  
**AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling her in that behalf, for the purpose of informing road users of entry requirements on roads for which Oxfordshire County Council is the traffic authority, hereby:-

1. authorises the erection at or within 5 metres of the site shown schematically on the attached drawing plan numbered GT50/120/0037-1 of a traffic sign consisting of a plate (hereinafter referred to as “the authorised plate”) conforming as to size, colour and character with that shown in the attached drawing numbered GT50/120/0037-2; and
2. directs that the authorised plate shall only be used with the sign shown in Schedule 3, Part 2, Item 17 (diagram 952) of the Traffic Signs Regulations 2016 (Part I of SI 2016/362, “the 2016 Regulations”); and
3. directs that it is a condition of this authorisation that the authorised plate may be placed only to indicate the effect of a corresponding Traffic Regulation Order when the authorised plate is used with the sign shown in Schedule 3, Part 2, Item 17 (diagram 952), and
4. directs that the provisions of Schedule 3, Parts 1 to 5 of the 2016 Regulations shall apply to the authorised plate in the same manner as they apply to the sign described in Schedule 3, Part 3, Item 15 of those Regulations; and
5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised plate at or near the said sites shall continue to have effect only until such day as may be appointed by one month’s notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised plate and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.



The provisions of Regulations 5, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised plate in the same manner as they apply to the sign described in Schedule 3, Part 3, Item 15 of those Regulations.

4. directs that the provisions of Schedule 3, Parts 1 to 5 of the 2016 Regulations shall apply to the authorised plate in the same manner as they apply to the sign described in Schedule 3, Part 3, Item 15 of those Regulations; and
5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised plate at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised plate and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

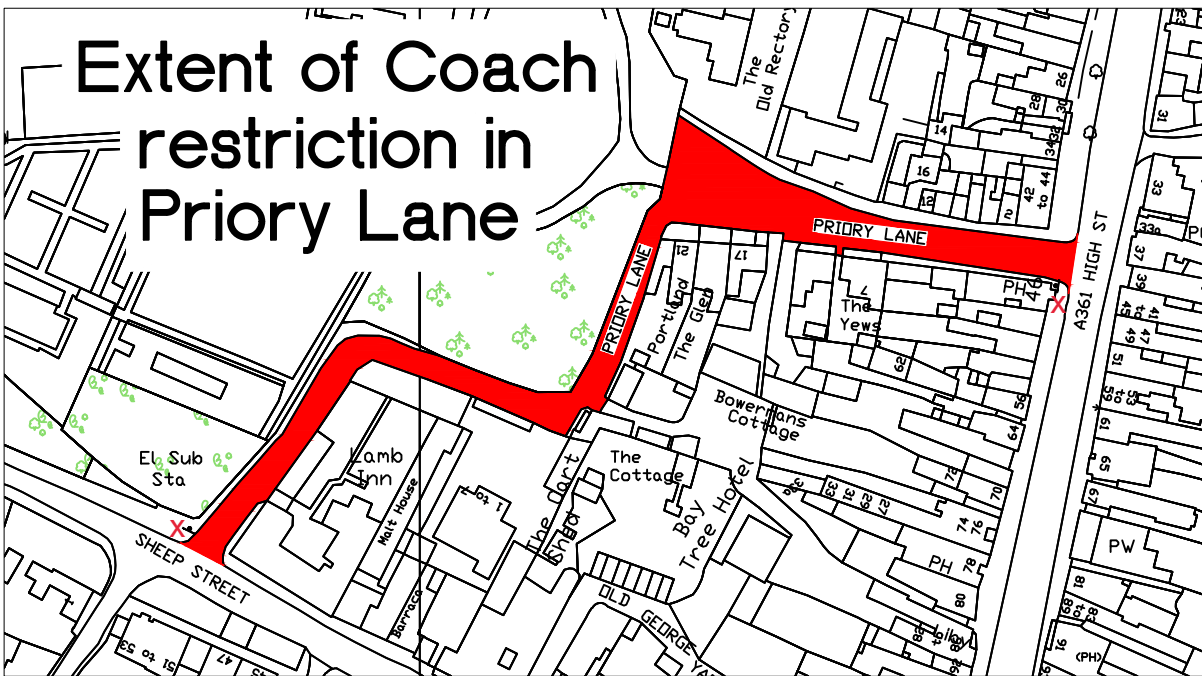

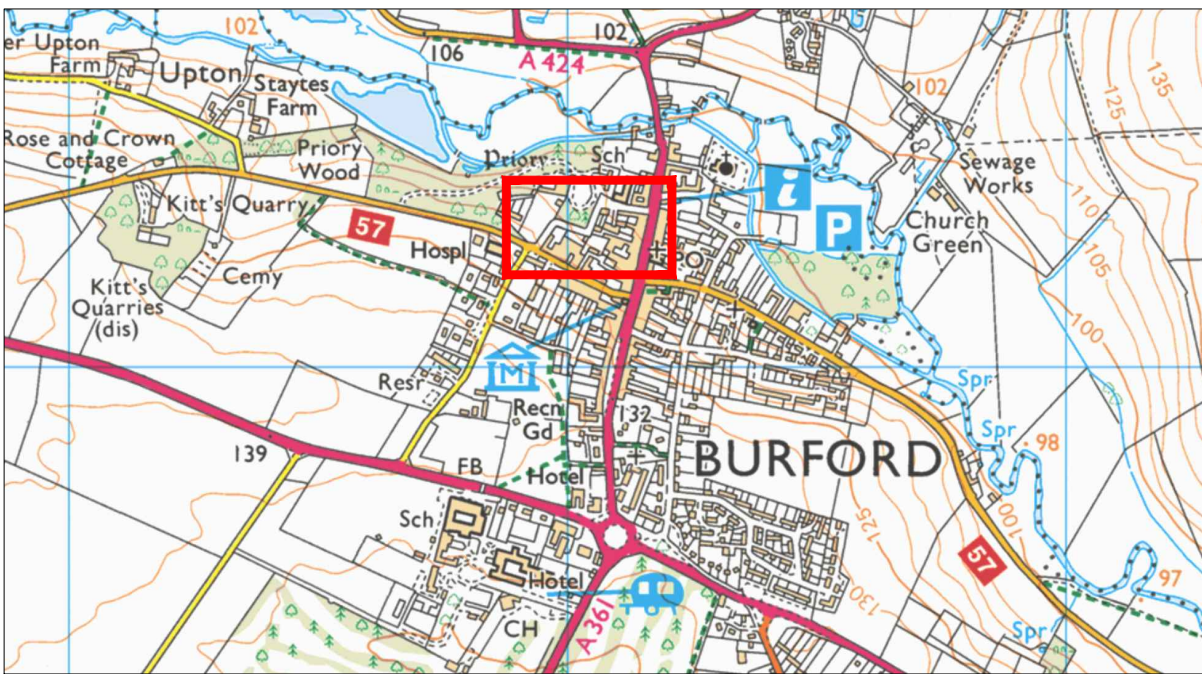




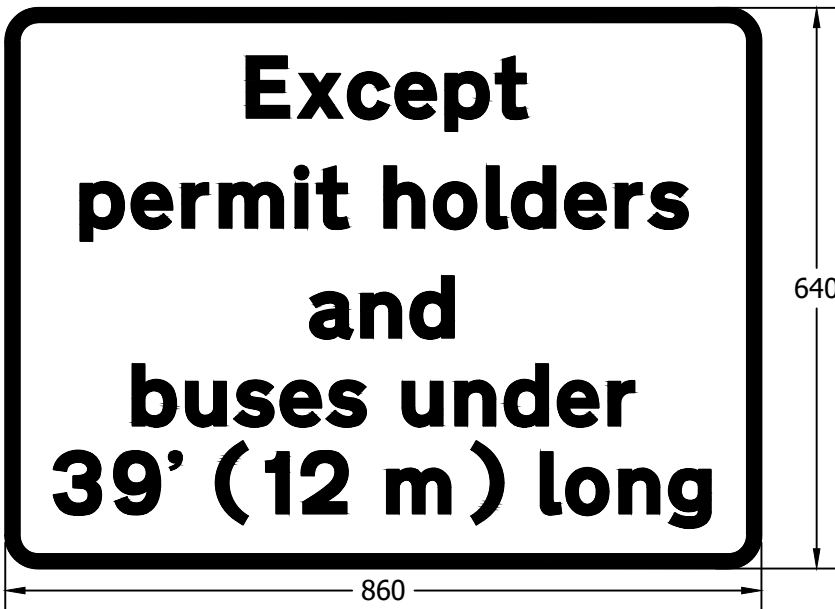
Coach restriction terminal signing
