Secretary of State for Transport's traffic authorisation of traffic signs for the purpose of informing road users of provisions for e-taxis on roads for which Warwickshire County Council is the traffic authority.

ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling her in that behalf, for the purpose of informing road users of provisions for e-taxis on roads for which Warwickshire County Council is the traffic authority, hereby:-

1. authorises the erection at the said sites of a traffic sign (hereinafter referred to as “the authorised sign A”) conforming as to size, colour and character with that shown in the attached drawing numbered GT50/182/0018-1 save that (a) the x-height may be varied to not less than 15 mm and not more than 40 mm; (b) the legend indicating the time of day may be omitted or varied to a permitted expression of time periods, days and dates; and (c) an arrow pointing to the left or to the right where indicating the beginning of, or a change in, a restriction or prohibition may be included; and
2. authorises the placing at the said sites of a road marking (hereinafter referred to as “the authorised marking A”) conforming as to size, colour and character with that shown in Diagram 1028.2 of Schedule 7, Part 4, Item 5 of the 2016 Regulations save that the legend “TAXIS” shall be replaced with the legend “E-TAXIS”; and
3. directs that the authorised marking A may only be used in combination with the authorised sign A; and
4. directs that the authorised sign A and the authorised marking A shall only be placed to indicate the effect of a corresponding Traffic Regulation Order; and
5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign A and the placing of the authorised marking A at or near the said sites shall continue to



have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign A and the authorised marking A and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 5, 6, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign shown in Schedule 4, Part 3, Item 1 of those Regulations.

The provisions of Schedule 4, Parts 2 and 6 of the 2016 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign shown in Schedule 4, Part 3, Item 1 of those Regulations.

The provisions of Regulations 7, 9 and 10 of the 2016 Regulations shall apply to the authorised marking A in the same manner as they apply to the road marking shown in diagram 1028.2 in Schedule 7, Part 4, Item 5 of those Regulations.

The provisions of Schedule 7, Parts 3, 5, 6 and 7 of the 2016 Regulations shall apply to the authorised marking A in the same manner as they apply to the road marking shown in diagram 1028.2 in Schedule 7, Part 4, Item 5 of those Regulations.

4. directs that the authorised sign A and the authorised marking A shall only be placed to indicate the effect of a corresponding Traffic Regulation Order; and
5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign A and the placing of the authorised marking A at or near the said sites shall continue to



have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign A and the authorised marking A and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 5, 6, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign shown in Schedule 4, Part 3, Item 1 of those Regulations.

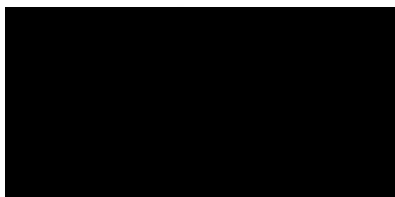

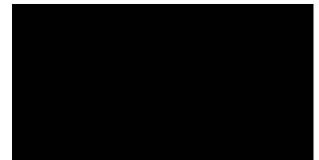

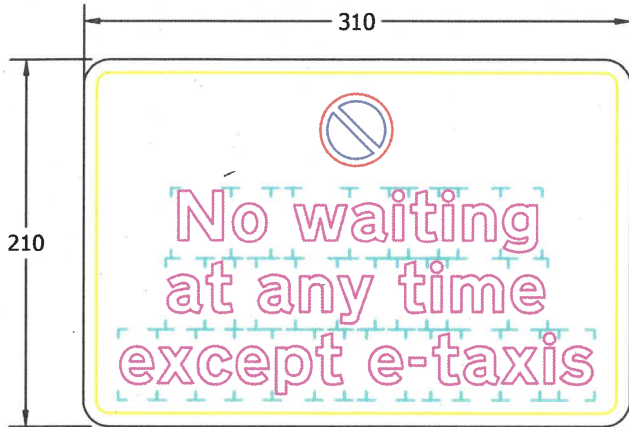
