## Authorisation of traffic signs and special directions

#### Accessible transcript

Secretary of State for Transport's traffic authorisation of traffic signs for the purpose of informing drivers of charges on roads for which Oxfordshire County Council is the traffic authority.

### ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling her in that behalf, for the purpose of informing drivers of charges on roads for which Oxfordshire County Council is the traffic authority, hereby:-

- 1. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/120/0043-1; save that
  - a) the x-height may be varied;
  - b) references to the time period may be omitted or varied to a permitted expression of time periods, days and dates;
  - c) subject to the design rules set out in The Traffic Signs Manual Chapter 7, the size of the roundel and the size of the motor car symbol may be varied; and
- directs that the provisions of Schedule 3, Parts 1 to 5 of the 2016 Regulations shall apply to the authorised sign A in the same manner as they apply to the signs described in Schedule 3 of those Regulations; and
- 3. directs that it is a condition of this authorisation that the authorised sign A may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and
- 4. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/120/0043-2 save that
  - a) the x-height may be varied;
  - b) references to the time period may be omitted or varied to a permitted expression of time periods, days and dates;



- c) subject to the design rules set out in The Traffic Signs Manual Chapter 7, the size of the roundel and the size of the motor car symbol may be varied;
- d) the expression of distance in the top panel may be varied as appropriate or omitted;
- e) subject to the design rules set out in The Traffic Signs Manual Chapter 7, an arrow pointing horizontally to the left or to the right may be added in the top panel; and
- 5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A and B and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 5, 6, 7, 8 and 11 of Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, "the 2016 Regulations") shall apply to the authorised sign A in the same manner as they apply to the signs described in Schedule 3 of those Regulations.

The provisions of Regulations 5, 6, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign B in the same manner as they apply to the sign shown in diagram 818.6 in Schedule 8, Part 4, Item 3 of those Regulations.




