Accessible transcript

Secretary of State for Transport's traffic authorisation of traffic signs for the purposes of providing information to road users at appropriate locations on roads for which National Highways is the traffic authority.

The following pages contain a copy of the text from the Secretary of State for Transport's traffic authorisation regarding the above traffic signs.

**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65****AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all powers enabling her in that behalf, for the purposes of providing information to road users, hereby:-

1. authorises at appropriate locations on roads for which National Highways is the traffic authority, the display of the following legends (hereinafter referred to as “the authorised legends”) on variable message signs (VMS) as defined in Schedule 1 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, “the 2016 Regulations”):
 - a. (Date) (time) (A/M*) (J*(-J*)) (Remote) tech(nology) maintenance / repairs (in progress) (until) (time) (take extra care)
 - b. (Date) (time) (A/M*) (J*(-J*)) No signs / signals / Disruption to signs / signals / Upgrading technology (A/M*) (J*(-J*)) (until) (time) (take extra care)
 - c. (Date) (time) (A/M*) (J*(-J*)) No SOS phones (for * miles) (until) (time)
 - d. (A/M*) (J*(-J*)) (Power loss / failure) (No signs / signals / Signal disruption) (until) (time) (take extra care)
2. directs that any of the authorised legends shall be individually displayed only at such times as are appropriate to indicate that the conditions it describes apply and that, when not displaying any message, the sign face of the VMS shall remain blank; and
3. directs that the authorised legends may be displayed in either sentence case as shown or in capitals; and
4. directs that brackets used in the authorised legends do not form part of the legend but indicate text or information which may or may not be displayed as part of the authorised legend; and

5. directs that “Date” and “time” refer to expressions of dates and times which when included must comply with Schedule 18 of the 2016 Regulations; and
6. directs that forward slashes used in the authorised legends do not form part of the legend but are used to show where alternatives can be selected and that only one of the alternatives can be displayed on one sign at any one time; and
7. directs that asterisks used in the authorised legends do not form part of the legend but shall be replaced by numbers indicating motorway or road numbers, junction numbers or measures of distance; and
8. directs without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that use of the authorised legends shall continue to have effect only until such day as may be appointed by one month’s notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised legends and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Schedule 16 to the 2016 Regulations shall apply to the authorised legends as they apply to the legends prescribed in Schedule 16 to those Regulations.

This authorisation replaces the earlier one dated 23 May 2023 under reference GT50/198/0099 which is hereby revoked

2. directs that any of the authorised legends shall be individually displayed only at such times as are appropriate to indicate that the conditions it describes apply and that, when not displaying any message, the sign face of the VMS shall remain blank; and
3. directs that the authorised legends may be displayed in either sentence case as shown or in capitals; and

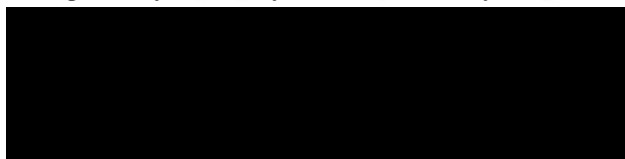

The provisions of Schedule 16 to the 2016 Regulations shall apply to the authorised legends as they apply to the legends prescribed in Schedule 16 to those Regulations.

This authorisation replaces the earlier one dated 23 May 2023 under reference GT50/198/0099 which is hereby revoked
