Accessible transcript

Secretary of State for Transport's traffic authorisation of traffic signs for the purpose of informing road users of conditions attached to parking places for car club electric vehicles on roads for which Brighton and Hove City Council is the traffic authority.

ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling her in that behalf, for the purpose of informing road users of conditions attached to parking places for car club electric vehicles on roads for which Brighton and Hove City Council is the traffic authority, hereby:-

1. authorises the erection at appropriate sites of a traffic sign (hereinafter referred to as “the authorised sign”) conforming as to size, colour and character with that shown in the attached drawing numbered GT50/014/0020-1 save that
 - (a) the x-height may be varied to not less than 15 mm and not more than 40 mm;
 - (b) a permit identifier may be added;
 - (c) an arrow pointing to the left or to the right may be added;
 - (d) the name and/or logo of the traffic authority may be added; and
2. directs that the road marking with associated legend “CAR CLUB” shown in Diagram 1028.4 of Schedule 7, Part 4, Item 6 to the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, “the 2016 Regulations”) may be used with the authorised sign; and
3. directs that the authorised sign shall only be placed to indicate the effect of a corresponding Traffic Regulation Order; and
4. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign at or near the said sites shall continue to have effect only until such day as may be appointed by one month’s notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.



The provisions of Regulations 5, 6, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised sign in the same manner as they apply to the sign shown in Schedule 4, Part 4, Item 2 of those Regulations.

The provisions of Schedule 4, Parts 2, 4 and 6 of the 2016 Regulations shall apply to the authorised sign in the same manner as they apply to the sign shown in Schedule 4, Part 4, Item 2 of those Regulations.

The provisions of Schedule 4, Parts 2, 4 and 6 of the 2016 Regulations shall apply to the authorised sign in the same manner as they apply to the symbol shown in Schedule 4, Part 5, Item 5 of those Regulations.

2. directs that the road marking with associated legend “CAR CLUB” shown in Diagram 1028.4 of Schedule 7, Part 4, Item 6 to the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, “the 2016 Regulations”) may be used with the authorised sign; and
3. directs that the authorised sign shall only be placed to indicate the effect of a corresponding Traffic Regulation Order; and
4. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign at or near the said sites shall continue to have effect only until such day as may be appointed by one month’s notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

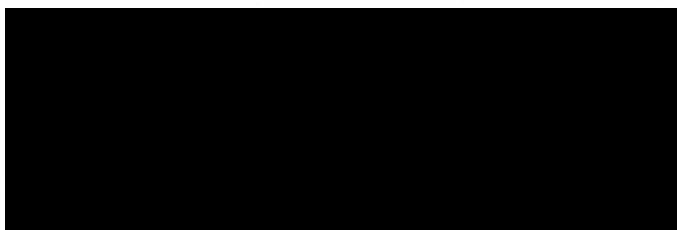

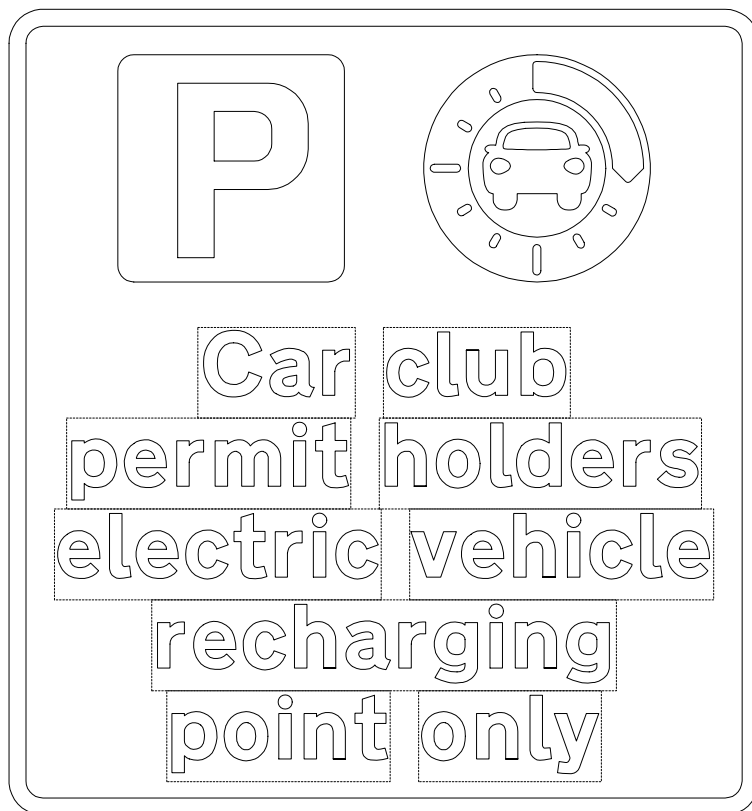
