Accessible transcript

Secretary of State for Transport's traffic authorisation of traffic signs , for the purpose of informing drivers of parking restrictions on roads for which Liverpool City Council is the traffic authority.

ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65

AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of her powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling her in that behalf, for the purpose of informing drivers of parking restrictions on roads for which Liverpool City Council is the traffic authority, hereby:-

1. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as “the authorised sign A”) conforming as to size, colour and character with that shown on the attached drawing numbered

GT50/069/0033-1 save that:-

- a) the name of the traffic authority may be added in the top panel;
 - b) the time period in the top panel may be varied or omitted;
 - c) the time period in the top panel may be replaced by the legend “at all times”;
 - d) the permit identifier in the lower panel may be varied;
 - e) additional permit identifiers may be added in the lower panel;
 - f) the legend “Resident permit” may be varied to “Permit”;
 - g) the numerals and legend in the lower panel indicating the parking restrictions may be varied; and

2. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as “the authorised sign B”) conforming as to size, colour and character with that shown on the attached drawing numbered

GT50/069/0033-2 save that:-

- a) the x-height may be varied between the range 15 mm to 40 mm;
 - b) the name of the traffic authority may be added;



- c) the time period may be varied or omitted;
- d) the time period may be replaced by the legend "At all times";
- e) the permit identifier may be varied;
- f) additional permit identifiers may be added;
- g) the legend "Resident permit" may be varied to "Permit";
- h) the numerals and legend indicating the parking restrictions may be varied; and

3. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign C") conforming as to size, colour and character with that shown on the attached drawing numbered GT50/069/0033-3 save that:-

- a) the x-height may be varied between the range 15 mm to 40 mm;
- b) the time periods may be varied or omitted;
- c) the legend "NOT TODAY" in the bottom panel may be replaced by a date or dates or day or days or a combination of both; and

4. directs that it is a condition of this authorisation that the authorised signs A to C may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and

5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A to C at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A to C and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 5, 6, 7, 8 and 11 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2016/362, “the 2016 Regulations”) shall apply to the authorised sign A in the same manner as they apply to the sign shown in Schedule 5, Part 3, Item 5 of those Regulations.

The provisions of Regulations 5, 6, 7, 8 and 11 of the 2016 Regulations shall apply to the authorised signs B and C in the same manner as they apply to the signs shown in Schedule 4, Parts 3 and 4 of those Regulations.

The provisions of Schedule 5, Parts 1 to 5 of the 2016 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign shown in Schedule 5, Part 3, Item 5 of those Regulations.

The provisions of Schedule 4, Parts 2 to 6 of the 2016 Regulations shall apply to the authorised signs B and C in the same manner as they apply to the signs shown in Schedule 4, Parts 3 and 4 of those Regulations.

2. authorises the erection at appropriate sites on the said roads of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown on the attached drawing numbered

GT50/069/0033-2 save that:-

- a) the x-height may be varied between the range 15 mm to 40 mm;
- b) the name of the traffic authority may be added;

- c) the time period may be varied or omitted;
- d) the time period may be replaced by the legend "At all times";
- e) the permit identifier may be varied;

- b) the time periods may be varied or omitted;
- c) the legend "NOT TODAY" in the bottom panel may be replaced by a date or dates or day or days or a combination of both; and

4. directs that it is a condition of this authorisation that the authorised signs A to C may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and

5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A to C at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A to C and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.


