### **'ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing drivers of a guided busway between Ashton Vale and Temple Meads in Bristol, hereby:-

- authorises the placing at or within 5 metres of the sites referenced "M15" on the attached set of plans numbered GT50/015/0026-1 of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking A") conforming as to size, colour and character with the marking shown on the attached drawing numbered GT50/015/0026-2; and
- authorises the placing at or within 5 metres of the sites referenced "M18" on the said set of plans of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking B") conforming as to size, colour and character with the marking shown on the attached drawing numbered GT50/015/0026-3; and
- authorises the placing at or within 5 metres of the sites referenced "M20A" on the said set of plans of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking C") conforming as to size, colour and character with the marking shown on the attached drawing numbered GT50/015/0026-4; and
- 4. authorises the placing at or within 5 metres of the sites referenced "M20B" on the said set of plans of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking D") conforming as to size, colour and character with the marking shown on the attached drawing numbered GT50/015/0026-5; and
- 5. authorises the erection at or within 5 metres of the sites referenced "S3" on the said set of plans of a sign consisting of a plate (hereinafter referred to as "the authorised plate A") conforming as to size, colour and character with the plate shown on the attached drawing numbered GT50/015/0026-6; and

- authorises the erection at or within 5 metres of the sites referenced "S4" on the said set of plans of a sign consisting of a plate (hereinafter referred to as "the authorised plate B") conforming as to size, colour and character with the plate shown on the attached drawing numbered GT50/015/0026-7; and
- authorises the erection at or within 5 metres of the sites referenced "S9" on the said set of plans of a sign consisting of a plate (hereinafter referred to as "the authorised plate C") conforming as to size, colour and character with the plate shown on the attached drawing numbered GT50/015/0026-8; and
- 8. authorises the erection at or within 5 metres of the sites referenced "S16" on the said set of plans of a sign consisting of a plate (hereinafter referred to as "the authorised plate D") conforming as to size, colour and character with the plate shown on the attached drawing numbered GT50/015/0026-9; and
- directs that the authorised plate A shall be used with the sign to diagram 616 in Schedule 3, Part 2, Item 10 of the Traffic Signs Regulations 2016 (Part 1 of S.I. 2012/362, "the 2016 Regulations"); and
- 10. directs that the authorised plate B shall be used with the sign to diagram 562 in Schedule 2, Part 2, Item 56 of the 2016 Regulations; and
- 11. directs that the authorised plates C and D shall be used with the sign to diagram 619 in Schedule 3, Part 2, Item 12 of the 2016 Regulations; and
- 12. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised markings A-D and the authorised plates A-D shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised markings A-D and the authorised plates A-D and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 7 and 8 of the 2016 Regulations shall apply to the authorised markings A-D in the same manner as they apply to the road marking shown in diagram 1048.5 in Schedule 9, Part 6, Item 15 of those Regulations.


